(the communicant and the Party concerned are invited to coordinate and provide a common answer to the questions of the Committee)

- 1. Please provide a clear description on how the regular, simplified and "de facto" environmental impact procedures work at the federal and provincial level and explain how they relate to the standing criteria, as provided for in article 9, paragraph 2, of the Convention. (During the discussion at the thirtieth meeting, it was suggested that the Party concerned prepares the first draft of the response and the communicant comments/adds, with a view to submitting a common answer to the Committee).
- 2. Please provide a list of the procedures available under article 9, paragraph 3, of the Convention and indicate standing criteria for NGOs in this regard. (During the discussion at the thirtieth meeting, it was suggested that the communicant prepares the response and the Party concerned comments/adds, with a view to submitting a common answer to the Committee).
