# GEORGIANA IORGULESCU EXECUTIVE DIRECTOR CENTRE FOR LEGAL RESOURCES

Following your letter no. 9 dated January 14<sup>th</sup>, 2011, registered at the President's Office of the Court of Appeal Bucharest under no. 1/576/C from the date of January 14<sup>th</sup>, 2011, we communicate you the following:

On the roll of the Court of Appeal Bucharest – VIII.th Department for administrative and fiscal contentious matters, the file no. **39312/3/2009**, having as parties the *Centre for Legal Resources* – as plaintiff - and the *National Integrity Agency* – as defendant - was filed on the date of May 13<sup>th</sup>, 2010, with a first hearing term on the date of June 15<sup>th</sup>, 2010;

At the hearing dates from June 15<sup>th</sup>, 2010, September 28<sup>th</sup>, 2010 and October 26<sup>th</sup>, 2010 the case judgment has been postponed with a view to the issuing of a letter by the National Integrity Agency (N.I.A.) in order to proceed to the declassification of the Order no. 561/2008 of N.I.A., according to the provisions of the Law no. 182/2002 and of the Government Decree (H.G.) no. 585/2002, taking into consideration that the chairman of the judge panel doesn't hold a N.R.O.C.I. (Romanian National Registry Office for Classified Information) certificate.

On the hearing held on the date of December 7<sup>th</sup>, 2010, the forwarding of the case to the Judge Panel 4 on the Merits has been ordered, according to the Decision of the Management Board of the Court of Appeal Bucharest no. 19/2010, requested by you.





According to the provisions of art. 25 paragraph (7) under the Decision of the Superior Council of Magistracy no. 387/2005, "the decisions of the Management Board are not public".

With regard to these provisions, we communicate to you in the following an excerpt from the Decision no. 19/2010 of the Management Board of the Court of Appeal Bucharest, by which the following have been decided:

- "Art. 4 On the grounds of art. 95 paragraph 3 under the Internal Regulations of the courts of justice, until the resolution on a legislative way of the aspects regarding the judgment of the files with classified documents, the following rules valid for all department have to be observed:
- (1) Within each department, after the random distribution of a file with classified documents, in case that the judge/judges who compose the judge panel do not hold N.R.O.C.I. certificates or they do not correspond to the level of classification, the file is considered distributed to the next judge panel, which determines in the matter and has in its composition a judge/judges who hold(s) N.R.O.C.I. certificates corresponding to the level of classification;"
