Dear Ms Smagadi

With regard to the UNECE invitation of the 6th November 2012 and the comment made in relation to submission of additional information, I would like to take this opportunity to update yourself and the Committee in a concise manner on some developments in the Communication, since I submitted my response to your questions on the 24th September 2012.

Parliamentary Enquiry

On page 16 of my Response (Question 3 to the Communicant), I made reference to the Engineering Institutions and their submission to the Scottish Parliamentary Enquiry. The Parliamentary Committee published their report on the 23rd November 2012¹. It has 295 paragraphs of which paragraphs 8 to 10 state:

- 8. "The Committee heard a range of views on the extent to which renewable energy generation leads to a reduction of greenhouse gas (GHG) emissions because of the requirement to have thermal generation running at suboptimal efficiency as a back up to intermittent supply".
- 9. "The Committee asks that the UK Government seeks clarity from the Committee on Climate Change on this issue and confirms that running thermal plant at lower efficiency has been accounted for in its calculations".
- 10. "The Committee further seeks clarity from the National Grid and the UK Government on whether —reducing the carbon intensity of the grid takes account of electricity which is generated from thermal plant but, due to despatch decisions, does not make it as far as the grid, whether this is expected to be a continuing issue, and, if so, for how long".

No mention is made of the Aarhus Convention or the known problems in Scotland with regard to Access to Justice in Environmental Matters.

Internal Review under Regulation 1367/2006

In relation to page 8 of my Response (Question 2 to the Communicant) and the Internal Review request under Regulation 1367/2006, the EU Commission did reply with a request for further information on the 5th October 2012². A response to this was prepared and submitted within the three week time period, documenting in particular the large number of affiliate organisations to the European Platform Against

Wind farms (EPAW), which are utilising the measures of Environmental Democracy and Environmental Legislation in relation to the massive roll out of wind energy projects throughout the EU-27. Since then there has been no further contact.

Domestic Remedies - UK Ombudsman

As was highlighted on Page 19 of my Response (Question 4 to the Communicant), the UK Ombudsman was contacted, who has since referred the matter back to the Information Commissioner, see correspondence below. However, with regard to Article 5 (2) of the Convention, please see the position below. In essence there is no system in the UK for ensuring the transparency of information on the environment.
