Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Ukraine with provisions of the Convention in connection with the decision-making for the construction of biofuel and waste incineration plants (ACCC/C/2013/87)

On 13 May 2013, the secretariat of the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) received the above communication addressed to the Compliance Committee under the Convention. The communication concerns compliance by Ukraine with the provisions of the Convention on access to information and public participation in relation to the decision-making process for the construction of biofuel and waste incineration plant in the city of Donetsk.
