6.8 Overall/other comments on local economic development proposals

- A craft/beach shop with refreshments close to, or adjacent the car park/toilets on beach road in the village would be ideal, staffed by local people, it could sell and raise awareness of local crafts and arts (close enough to village, but involving forest, beach and dune). If it was diverse enough (and good enough) it would be viable winter as well as summer. e.g. selling beach balls/windbreaks in summer and woolly hats and dog coats in winter (and all year round, arts and crafts, reflecting natural resources and interests)
- I wouldn't mind paying £20 per annum
- This is ???? If you want to control vehicle numbers why suggest?????
- There will be no local economic benefits increase fees means increased funds for Forestry Commission

- Does barrier have a "FULL" sign? Annual fee seems fair to me
- Important to involve the local community and to generate income for local residents. However, there is a risk of spoiling the area with over commercialisation - that is, in the forest/beach area itself. Would it be possible to increase trade in the town itself?
- This can be contentious and probably outside your control in real terms. Think of the Snowdonia Green Key fiasco.
- This is a very special area. I don't really want to see any more film crews taking over the area, nor do I want ice cream, burgers or anything else being sold within boundaries. All these services can be found in Newborough Village. If visitors want these facilities direct them to Benllech, Rhosneigr etc. This area is important for wildlife and that should take precedent over generating income for local business.
- There could be "Green Ways" of increasing benefits Newborough could be a flag ship site for: Park and Ride from the village into a fume/free environment - protected by those wishing to conserve the beauty and peace of this unique and wild area ("A Venice of Anglesey"?)
- I approve of the good quality local ice cream on sale in the car park but would not approve of the expansion of this facility to include cooked food. Some sort of outlet for local produce in the village might be a good idea (picnic baskets). Notice Board in the village with map of Area?
- The beach and forest is one on the last remaining safe, wild areas on Anglesey where people can make their own entertainment without the pressures on parents to buy things it teaches children that the area must be looked after and allows flora and fauna to flourish -where else can you see 29 Bee Orchids in a small stretch of coastal path?
- How much of the barrier income reaches (a) Forestry Commission Wales, (b) is spent in the area, (c) on this consultation)
- As long as money comes back to Newborough Area.
- At present there is very little for visitors to spend money on in the village. A child friendly pub somewhere close by could maybe give some employment.
- Loads of potential, e.g. section for Woodland Crafts, Osier Work, Rustic Work
 Interwoven Fence, Wattle Fencing, Hedge layering. Sale of products in Newborough.
- How do local people get a key fob??
- When are you going to realise that less people using the forest is what the population of Newborough are after.
- They are extremely unpleasant to people who shop in the village and having heard it first hand the usual comment is we hate the f****g English! they don't realise I am Welsh born and a Welsh speaker says it all!
- Local people should realise what's on their own door step and make their own decisions as to how they could capitalise on it.
- The existing signage to the Forest from the A4080 in non existent. Park and Ride could reduce impact on Newborough improve existing service via Sea Zoo, Foel Farm, Birdworld, Model Village Forest Cob, Malltraeth etc. No wonder people don't use the village shops etc.
- Set up organised, timed and planned Tourist Walks, starting in the village and leading through the Forest and down on to the beach, then on to Llanddwyn Headland and Buildings, then down beach towards Malltraeth, then back through wood. Advertising and planning would be needed. Easter to late October and charge a fee.
- Someone with knowledge of area would be required to act as guides.
- Improve the village image.

- Various points above would need careful consideration to prevent alienation of so many of the beach users.
- A beach café could provide local people with an income apart from staffing which should ban any smoking by
- employees anywhere near the café. Home made soup, cakes jams etc would give extra income to some people, to be sold on the premises. Also if it incorporated a small shop, visitors like nothing better than to be able to buy local produce. Referring back to the cafe idea, when people have paid £2.00 to access the area they should be able to get proper refreshments. The Forestry Commission in the Galloway region have got lovely wood
- cabins for this purpose. They combine information with a shop and cafe, Lovely after a long walk.
- Car park capacity. People need lines to guide them to park. If they parked in designated bays as they are used to at Tesco's the capacity would go up straight away, without having to even expand the car park. People leave a wide gap between them and the next car. Barrier Management Too many people in "illegally" (spare fire trick,). Sort those people out first before penalizing honest locals. Suggest CCTV CONVERT?? & £50 FINE

- Having lived on the Island for 13 years with my wife coming from Birmingham in early 1994 approx we did enjoy Bingo sessions at Pritchard Jones Institute, but this has discontinued. By what we would deem as lack of villager interest etc
- Need 5 star hotel to attract pennies from heaven!
- The barrier charges in the winter season should be reduced to a minimum / free. Increase charge for summer to compensate. A lot of money in winter to walk the dog for 1 hour. Allow dogs on island during winter.
- Local residents should not have to pay towards gaining access to their own facilities I.e. the Forest, Beach, car parking, toilet facilities etc, this wonderful mountain vista on their own doorstep should not come at a price for locals.
- Use local income for ???? Of local residents (??? Rubbish etc)
- No objections as long as the non-commercial, restricted access via car park cost continues.
- Some for of sign in the village to indicate the car park is full would reduce stress on both staff and public
- Traffic has increased through the village of Newborough substantially as the popularity
 of the Forest has increased. If the Forest is to be more aggressively marketed the
 possibility of an alternative route to the forest need to be investigated. A serious
 accident will occur soon!
- The litter on the stretch of road from the de-limiting signs for the village as far as the main gates (opposite Llyn Parc Mawr) is an enormous problem. I pick up 3 bags full on this stretch of road 2 or 3 times a week (filling up our bin). Visitors driving to the car park at the Malltraeth end of the forest must have a very bad impression. Most of the rubbish is thrown out of cars (I think) it increases in summer. There is no provision for litter cleaning on this road.
- A high percentage of the Key Fob fee should end up in the local economy. At present the local population receives no benefit from the fees. To increase the capacity of the beach car park would only generate more traffic through the village. Need to improve management of the traffic. To improve existing paths is commendable but the new paths should be created as there are enough paths in the forest and Warren area

- already. More paths would only lead to more human interference for wild life and flora. San dune areas have suffered enough from tourism.
- the concern for cutting more trees to enable parking is a problem but I personally think that speed ramps from the church all the way to the junction in the village would be more beneficial to stop these 'tourists!!

 might involve a red squirrel trail (circular walk) from the main car park and associated
 with visitor centre. This is already being successfully done at Formby in that there is
 currently a major new investment by NT at Formby into enhancing their red squirrel

- consideration of parking and economic benefits. The village needs to be more attractive to visitors - flowers,
- colourful houses. The groups of youths and older ones on street corners appear
 threatening tourists and local alike. Vehicle numbers are already restricted fire
 safety. A nominal increase in the key fob price but do not force local people out of
 forest through to high prices.
- coach access to the beach car park for school groups would help in promoting educational use
- why are you pretending to be interested in improving facilities attracting more people
 to visit and then suggest controlling number of vehicles numbers by raising key fob
 prices this suggests that you are actually only interested in generating extra cash ie
 extra taxes
- open up area of forest for mountain biking track organised and income generating
- Newborough beach/warren works well as an unspoilt site we do however need better
 parking facilities there are areas where it is impossible to park due to heavy rain
 flooding areas. During the summer the area gets too crowded if people want cafes and
 shops let them look elsewhere

- Better signposting for beach & parking, café/visitor centre (Pritchard Jones) Beach car park? Speed restrictions in village (speed bumps, flashing lights 30mph sign), Local people can provide some voluntary or work/services but in conjunction with forestry commission CCW etc
- it would be helpful if a visitor centre was established in Newborough, with adequate parking, A visitor centre at the beach would be very exposed to theft etc - being so isolated, a centre near the village would also bring customers to other village businesses
- the key fob is very good value to someone like myself who visits the forest four times a
 week I don't object to a slight increase in the annual fee, however if fob holders are to
 be milked then you run the risk of loosing this revenue fob holders use the area all year
 round use the local shop and post office benefit from our trade, if the price increase
 became prohibitive it would be forced to go elsewhere
