7.9 Comments on landscape, geology and wildlife proposals

- It is important that some blocks (say 10HA each) of the existing pinus Nigra plantation remain intact as the plantation supports rare fungi such as Russula Torulosa, Russula Cessans, Sullus Flauidus and Pluteus Pouzarianu. Apart from Suillus Flavidus, these fungi are dependent on Pinus Nigra. This infers that some replanting of P Nigra will be necessary to maintain these fungi in future. The seaward side of the forest is richest for these fungi. Newborough forest is a National stronghold for Russula Torulosa.
- 1.How can one improve the landscape that is in situ already? It is remarkable and so diverse. Encouraging people to preserve what we already have and appreciating how wonderful it is, maybe we can improve. 2. People seem to be more interested in the archaeology of Ancient Celts the Geological Rock Formations. However, fossils and rare stones have always appealed. 3. The ornithologists have always visited and always shall it is because the area is so rich and diverse and Unspoilt.
- At least, at last we have some involvement of local people in their most precious natural asset. The challenge will be to keep people's interest, and encourage careful use of this area and to keep communications between locals, F.C.W. & CCW open.

- I think Newborough Forest and Warren is a magical place, particularly Llanddwyn Island. The dunes are wonderful too a very special area. The flora is quite unique. I visit the area very often throughout the year and feel privileged to be able to do so.

 Interception with an initiative such as the village heating scheme would provide long term benefit to the area.
- Not sure what this would entail. The forest is already a carbon reserve/sink.
- There are some recommendations for "improvement" which would, in my view spoil
 what is an existing, special place. The fact that effort is required to access some parts
 is part of the appeal to me. It is <u>not</u> commercialised, and <u>should</u> <u>not</u> be in the future.
- Allow forest to evolve in to a more diverse forest i.e. mixed forest (deciduous and evergreen (aerate soil) to encourage a greater diversity of species. Trying to balance human and no-human needs. However society is very biased towards human interest and education is required to re-adjust that balance.
- Not familiar with the terminology so cannot comment Strongly agree with the ideas set out.

7.10 What people think would NOT improve the area and what should not be done
