Re: Decision IV/9c of the Meeting of the Parties to the Convention on Access to Information, Public Participation in Decision-Making and Access to Justice in Environmental Matters (Aarhus Convention)

As you are aware, at its fourth session (Chisinau, 29 June-1 July 2011), the Meeting of the Parties to the Aarhus Convention adopted decision IV/9c on compliance by Kazakhstan with its obligations under the Convention. According to the decision, the Meeting of the Parties issued a caution which was to become effective on 1 May 2012, unless the following condition was satisfied: that you "had thoroughly examined, with appropriate involvement of the public, the relevant environmental and procedural legislation, as well as the relevant case law, to identify whether it sufficiently provides judicial and other review authorities with the possibility to provide adequate and effective remedies in the course of judicial review".

At its thirty-sixth meeting (27-30 March 2012), the Committee noted that you had provided the necessary information on time. However, the Committee also noted that it was not clear from the information you provided whether the above condition had been met. Therefore, you are now invited to clarify **how members of the public were involved in the process of examination of the relevant legislation and case law**.
