"On introducing changes and additions to the Order of the Minister of Environmental Protection of the Republic of Kazakhstan dated May 7, 2007 No. 135-p "On approval of the Rules of conducting public hearings"

I ORDER:

1. To introduce the following changes and additions to the order of the Minister of Environmental Protection of the Republic of Kazakhstan dated May 7, 2007 No. 135-p "On approval of the Rules of conducting public hearings" (registered in the Register of state registration of regulatory legal acts No. 4687, published by "Juridicheskaya Gazeta" dated June 15, 2007, No. 90 (1293)):

in the Rules of conducting public hearings (hereinafter - the Rules) approved by the mentioned order:

subparagraph 2) of paragraph 6 shall be stated as follows:

«2) in the form of a survey to take into account the opinion of the public concerned for the objects of III, IV categories, specified in subparagraph 6) of Article 57-2 of the Code;».

paragraph 10 shall be stated as follows:

«10. The Customer shall inform the interested public in the state and Russian languages not later than twenty calendar days before public hearings, with the following information:

day, time and place of public hearing;

the address of the place where the representatives of the public can familiarize themselves with the materials of the projects in paper form;

the name of the local executive body and contact details of the person responsible for organizing the public hearings;

the name of the state body on conducting state ecological expertise;

the name and contact information of the customer;

the name and contact details of the developer of the documentation;

address of the Internet resource of the local executive body, where the documentation for the project is posted;

e-mail address of the local executive body, where comments and suggestions shall be received;

address of the Internet resource or e-mail of the customer, where comments and suggestions shall be received;».

paragraph 19 shall be stated as follows:

«19. The results of public hearings shall be drawn up in a protocol, in the form specified in Annex 3 to the Rules. The protocol shall be drawn up taking into account the opinion of persons who participated in public hearings, not later than seven working days after the public hearings. The Protocol reflects comments and suggestions from the public concerned and the customer's position on the taking into account of each comment and proposal. The Protocol shall be signed by the chairman and the secretary of public hearings and shall be placed on the Internet resource of the local executive body not later than seven working days after the public hearings;».

paragraph 21 shall be stated as follows:

«21. Public hearings are considered valid at the obligatory participation of representatives referred to in subparagraph 1) and 2) of paragraph 4 of the Rules, with the exception of the customer (the developer of documentation);».

paragraph 24 shall be added with the eighth subparagraph of the following content:

«period of conducting public hearings in the form of a survey (not less than 20 calendar days), with indicating the date of the beginning and end of the receipt of comments and proposals;».

paragraph 27 shall be stated as follows:

«27. The responsible person of the local executive body together with the customer shall draw up a Protocol on conducting public hearings in the form of a

survey, not later than seven working days after conducting public hearings, according to the form specified in Annex 4 of the Rules. The Protocol reflects comments and / or proposals from the public concerned and the position of the customer on the taking into account of each comment and / or proposal;».

to add the following paragraph 28:

- «28. Protocol of public hearings shall be posted on the Internet resource of the local executive body not later than seven working days after conducting public hearings;».
- 2. The Department of Environmental Monitoring and Information of the Ministry of Energy of the Republic of Kazakhstan in the order established by the legislation of the Republic of Kazakhstan shall to ensure:
- 1) state registration of this order in the Ministry of Justice of the Republic of Kazakhstan;
- 2) within ten calendar days from the date of state registration of this order, forwarding its copy in printed and electronic form in Kazakh and Russian languages to the Republican State Enterprise on the right of economic management "Republican Center for Legal Information of the Ministry of Justice of the Republic of Kazakhstan" for official publication and inclusion in the Standard Bank of normative legal acts of the Republic of Kazakhstan;
- 3) within ten calendar days after the state registration of this order, forwarding its copy for official publication in periodicals;
- 4) placing this order on the official Internet resource of the Ministry of Energy of the Republic of Kazakhstan;
- 5) within ten working days after the state registration of this order in the Ministry of Justice of the Republic of Kazakhstan, submission of report on the implementation of activities provided for in subparagraphs 2) and 3) of this paragraph to the Legal Department of the Ministry of Energy of the Republic of Kazakhstan.
- 3. Control over the execution of this order is entrusted to the supervising Vice-Minister of Energy of the Republic of Kazakhstan.
- 4. This order is put into effect after ten calendar days after the day of its first official publication.
