**Re: Decision V/9i concerning compliance by Kazakhstan
with its obligations under the Aarhus Convention**

As you may be aware, pursuant to paragraph 8 of decision V/9i, the Government of Kazakhstan is requested to provide its second detailed progress report to the Committee by **31 October 2015** on the measures taken and the results achieved in the implementation of the recommendations set out in that decision.
