Description

To increase policy attention and support the creation of an enabling environment, small-scale water supply and sanitation systems have been a priority area for action in the Protocol's programmes of work since 2007. Good practices from across the region were collected in order to illustrates how countries in the region have taken the initiative to improve the situation of small-scale systems. The goal is to inspire national and local authorities by the case studies and good practices presented to take action towards reaching safe and sustainable water supply and sanitation services provided by small-scale systems. The collection of tools and good practices is supported by the outcomes of a survey on small-scale water supplies which was conducted under the Protocol.

The objective of the side event is to elaborate further on some of the case studies presented in the collection of tools and good practices. It aims at reaching out to policy makers both from the drinking-water as well as from the sanitation sector, to facilitate their collaboration, to give them further insight into how action has already been taken by other countries from within the region and to spark consideration of how this can be transposed to their settings.

A lot of experience exists within the European region with creating an enabling environment for improving the situation of small-scale water supplies and sanitation. The event will present policy makers with examples of such action, and inspire application of the proven tools and good practices across the region.
