RA Law "On Local Self-government"

 Article 37. The Activity of the Head of Community in the Sphere of Urban Development and communal infrastructures

As a mandatory power it is defined:

12) Organize waste management and sanitary services, as well as implement other authorities envisaged by RA Law "On Waste Management and Sanitary services"

RA Law 'On Local Self-government"

Article 38. Activity of community head in the field of land use

As a mandatory power it is defined:


- According to the legislation of the Republic of Armenia prepare land use schemes for communities and present to the Community Council for approval;
 - 1.1) Develop and prepare annual and four-year programs of community owned land alienation, which are the component part of the four-year development program of the community, and present to the Community Council for approval;
- 2) According to the urban development program documents of the community, as well as to the land use schemes, in case of community council agreement and defined terms, alienate or provide for use the community lands.
- 3) As prescribed by the law, supervise targeted utilization of the community lands within the administrative boundaries of the community, on the protection of land legislation requirements by the land users
- 4) Prevent and preclude unauthorized construction activities and land occupation, defined by the legislation.




"Armenia. Solid Waste Management Improvement" grant project

"Solid Waste management Solutions for Remote and Small Communities of Armenia"

- Objective: 1: Diagnostic study
- Objective: 2: Pre-feasibility study (for implementation of pilot and investment programs in remote and small communities)
- Beneficiary communities: Meghry-Agarak, Kapan Kajaran, Goris, Sisian regions of RA Syuniq marz and Yeghegnadzor-Vayq-Jermuk regions of RA Vayots Dzor marz together with the surrounding villages.
- <u>Expacted outcome</u>: Practical investment plan and policy of municipal solid waste management for small communities of Armenia, and till 2021 the start and implementation of primary investment program is foreseen.

Integrated Solid Waste Management in Vanadzor (Lori marz)

- Objective: To develop a Feasibility Study for the establishment of an integrated SWM system, considering the full range of waste streams to be managed by Vanadzor City and surrounding villages/municipalities
- Outcome` "The Final report of technical-economic statement" was discussed with stakeholders, on 31 October of year 2014 in the hall of RA Ministry of Territorial Administration took place the presentation of SWCM system (regional landfills), and proposed program for its implementation.

European Bank for Reconstruction and Development (EBRD) – (1)

"Kotayq Municipal Solid Waste Management" project

Objective: To establish a regional sanitary landfill in Hrazdan city for administrative territories of 7 communities of RA Kotayq marz and Sevan urban community of Gegharqunik marz.

Beneficiaries: Abovyan, Byureghavan, Yeghvard, Tsaghkadzor, Nor Hachn, Hrazdan, Charentsavan and Sevan urban communities

Costs/price 7 Mln. Euro – 3.5mln. credit, 3.5mln. grant

Outcome 1' On 19 December 2014 the agreements for credit, grant and implementation and support were assigned
