HGV/PSV T1 Driving Philosophy

- 1) Identify and demonstrate the qualities of a professional driver
- 2)Identify and demonstrate the responsibilities of large commercial vehicle drivers



HGV/PSV T2 Drivers' Welfare & Fitness to Drive

- 1) Identify factors to improve drivers' welfare
- 2) Interact with others at work for better well-being
- 3) Identify the negative impact of drugs on their ability to drive safely and responsibly
- 4) Identify the negative impact of alcohol on their ability to drive safely and responsibly
- 5) Identify the negative impact of fatigue on their ability to drive safely and responsibly
- 6) Identify how emotional states can have a negative impact on their ability to drive safely and responsibly
- 7) Identify the impact of their physical state on their ability to drive safely and responsibly



HGV/PSV T3 Traffic laws, rules, regulations and other relevant laws

- 1) Identify the purposes of road traffic act
- 2) Comply with the driving license requirements
- 3) Demonstrate the appropriate use of a motor vehicle and trailer on the road
- 4) Comply with road traffic controls
- 5) Identify how traffic regulations are enforced
- 6) Identify other laws, rules and regulations that apply to the road transport sector



HGV/PSV T4 Road signs, signals & markings

- 1) Identify and comply with warning signs
- 2) Comply with prohibitory signs
- 3) Comply with mandatory signs
- 4) Comply with give way and priority signs
- 5) Identify service signs
- 6) Identify place and road identification signs
- 7) Identify confirmatory signs
- 8) Identify direction signs
- 9) Comply with additional plates
- 10) Comply with road markings and Traffic Lights
- 11)Comply with background and edge markings



HGV/PSV T5 Basic Mechanical Principles

- 1) Optimize vehicle operating costs
- 2) Carry out minor repair of internal combustion engine
- 3) Identify the main components of the fuel system
- 4) Carry out minor maintenance of the electric system
- 5) Carry out minor maintenance of braking system
- 6) Carry out minor maintenance of steering system, tyres and wheels
- 7) Monitor vehicle maintenance schedules



HGV/PSV T6 Defensive driving

- 1) Identify the causes of road crashes and their consequences
- 2) Apply the standard Accident Prevention Formula for safe driving
- 3) Apply the basic defensive rules for safe driving
- 4) Approach and cross junctions safely
- 5) Apply the Hazard Drill for safe manoeuvre
- 6) Demonstrate the appropriate behaviour while driving
- 7) Manage night driving and fatigue
- 8) Avoid distraction for safe driving



HGV/PSV T7 HIV/AIDS Awareness

- 1) Identify the causes of HIV/AIDS
- 2) Avoid behaviour that can lead to contracting / transmitting HIV/AIDS
- 3) Identify the consequences of risky behavior
- 4) Identify other ways of transmitting HIV/AIDS
- 5) Apply common preventative methods
- 6) Undergo Voluntary Counselling & Testing
- 7) Apply Positive Living principles
- 8) Support People Living with HIV/AIDS



HGV/PSV T8 Customer Care

- 1) Define good customer care
- 2) Communicate effectively with customers
- 3) Meet the needs of customers
- 4) Support customers in using your service
- 5) Act politely and appropriately
- 6) Identify the need to drive considerately
- 7) Identify the need to load and position cargo on a PSV safely



HGV/PSV T9 Managing Incidents

- 1) Identify the risks at the scene of a crash or breakdown
- 2) Identify actions to take in the event of a crash
- 3) Interact appropriately with the authorities and other parties involved in the crash
- 4) Identify actions to take in the event of a breakdown
- 5) Identify actions to take if the vehicle is no longer fit to continue in service
- 6) Identify common causes of vehicle fires
- 7) Identify the type of fire extinguisher used on vehicles
- 8) Identify the correct operation of a fire extinguisher



HGV/PSV T10 First Aid

- 1) Perform basic First Aid
- 2) Identify the risks of and steps to avoid cross infection of HIV/AIDS



HGV/PSV T11 Transport Documentation

- 1) Identify the documentation required to cross a border with a vehicle
- 2) Identify the documentation required for the cargo or passengers
- 3) Identify the procedures at different border crossing points



HGV/PSV T12 Environment & Transport

- Identify types of emissions produced by motor vehicles
- Identify products of fuel combustion
- 3) Identify the direct impact of road transport pollution
- 4) Identify the indirect impact of road transport pollution
- 5) Identify steps taken by vehicle manufactures to reduce pollution
- 6) Identify measures to reduce motor vehicle pollution



HGV T13 Carrying a Load

- 1) Identify basics of load securing
- 2) Transport goods responsibly
- 3) Identify factor that affect vehicle stability
- 4) Comply with axle load limits
- 5) Identify classes of dangerous goods
- 6) Comply with maximum dimension limits
- 7) Carry and handle Dangerous Goods safely
