Terms of Reference

The Strategic Review of the Integrated Programme of Work for ECE COFFI and FAO EFC

Document prepared by the secretariat

Summary

This document provides an overview of the approach, methodology and timeline that will be used for the Strategic Review of the Integrated Programme of Work 2014-2017 for ECE COFFI and FAO EFC. This review has to be undertaken every four years. The outcome of the strategic review process during 2016-2017 will determine priorities for the Integrated Programme of Work up to 2021.

I. The strategic review process and the 2016-17 Strategic Review

1. The Strategic Review (SR) is an assessment of the Integrated Programme of Work (IPoW) for the ECE Committee on Forestry and Forest Industry (COFFI; also "Committee") and the FAO European Forestry Commission (EFC; also "Commission"), covering scope, structure and content of the programme, resources, methods, partnerships, outputs, and objectives and work of joint EFC and COFFI subsidiary bodies.

2. A first strategic review of the UNECE/FAO integrated programme of work on Timber and Forestry was undertaken in 2000 and the second in 2004. A third thorough strategic review took place in 2008, and resulted in the programme of work for the period 2008-2012. Extension of the programme's cycle by one year to 2013 made it compatible with the United Nations (UN) and FAO biennial programming structure. To maintain the cycles aligned, the fourth review was undertaken in the period 2012-2013 and the resulting revised programme of work for 2014-2017 was adopted by COFFI and EFC in 2013. This fifth review will be undertaken in the period of 2016-2017 and the resulting revised integrated program of work is expected to be adopted by the Committee and the Commission in 2017 for the four-year period 2018-2021¹.

3. The joint Bureaux (Executive Committee of EFC and Bureau of COFFI) at their meeting on 22 March 2016 in Geneva, Switzerland reviewed the Strategic Review document and endorsed the proposed timeline for the fifth Strategic Review (Chapter IV). The draft integrated programme of work would be prepared at the end of 2016 and presented in and expert workshop in order to give member States enough time to discuss it in 2017 and the Programme of Work 2018-21 is expected to be submitted for endorsement to the next joint sessions of COFFI and EFC in autumn 2017.

II. Purpose and Methodology

4. The main objectives of the review process are:

(a) the evaluation of the Integrated Programme of Work 2014-17, taking into consideration the results of implementation and past experience;

(b) the development of a proposal for the Integrated Programme of Work for 2018-2021.

The IPoW would then provide the basis for the biannual programmes 2018-19 and 2020-21 of the UNECE sub-programme 7 on Forestry and Timber and FAO Program of Work and Budget, and the joint work of the Committee and the Commission for the same years.

5. Based on experience gained from the previous review, it is proposed that the following principles be taken into account:

- The review should be as broad as necessary covering scope, structure and content of the programme, methods, partnerships, outputs, objectives, work of the EFC and COFFI joint subsidiary bodies,
- The review should be as inclusive as possible, through an all-encompassing process addressing Governments, the private sector and civil society at large, research and

academic institutions, as well as other partners participating in the work of UNECE and FAO in the region.

- A survey with open questions should be used, allowing respondents not only to provide feedback on relevance and output, but also to elaborate on specific topics and provide comments and suggestions for future thematic areas and work, and input to the new programme.
- The review process should be open and transparent, ensuring that the results will be publicly available and posted on the Joint Section's website. Individual inputs will be kept confidential.
- The review should be forward looking. As much as the review needs to assess and learn from the past, it should be oriented towards identifying and addressing new challenges and reviewing and structuring the integrated programme of work as appropriate.
- The review should make use of different means to gather the opinion and input of different stakeholders.
- 6. In particular, the following would be used:

A. Survey

7. The review should make use of a survey, to be made available in English and Russian, to be shared with the relevant stakeholders. The survey will have open-ended questions, allowing respondents to provide ideas and comments on future work.

8. It is suggested that only one comprehensive questionnaire be produced and shared with all relevant stakeholders. The Secretariat will then compile the results of the questionnaire and use this as a basis for discussion in review meetings and preparation of the proposal for the new programme. A draft set of open questions for the survey is available in Annex I.

B. Evaluation of the work of Teams of Specialists

9. Strategic review of Team of Specialists (ToS) work will be undertaken collectively, under management of the secretariat, by the respective ToS, through consultations using the survey questionnaire.

10. The results of these exchanges should also feed into the overall review process.

C. Assessment by the Secretariat of work and outputs

11. The ECE/FAO Forestry and Timber Section benefits from the direct experience of managing and implementing the programme of work, and it is often aware of challenges encountered in its execution. It is, therefore, proposed that the results of a secretariat internal review of the 2014-2017 IPoW and its implementation, as well as ideas for its future development of the 2018-2021 IPoW be compiled and made available for the review. This is not intended to be a self-evaluation, but more an assessment of challenges faced by the secretariat in implementing of the integrated programme of work, an evaluation of the structure of the integrated programme of work and suggestions for possible improvements.

D. Meetings with the COFFI and EFC and their subsidiary bodies to discuss the strategic review and new integrated programme of work

12. Involvement of COFFI and EFC and their subsidiary bodies, in particular the ECE/FAO Joint Working Party on Forest Statistics, Economics and Management, into the strategic review process and development of new IPoW 2018-2021 proposal is listed under following item III.

III. Timeline

13. The following schedule is proposed for the review process:

Phase I: Review of the IPoW 2014-2017

(a) 15 February 2016 to 15 March 2016

-Discussions on the methodology and scope of the Strategic Review

(b) 15 March to 30 March 2016

-Discussion on SR roadmap, review of a draft questionnaire for the IPoW stakeholders' survey at the joint Bureaux meeting (22 March 2016), approval of the Strategic Survey roadmap on the preparation of the IPoW 2018-2021.

-Information on the Strategic Review of IPoW at the joint ECE/FAO Working Party on Forest Statistics, Economics and Management (JWP).

(c) June 2016 to August 2016

-The questionnaire is shared with stakeholders in June and returned to the secretariat by the end of August.

(d) 1 September to 10 October 2016

-The secretariat prepares its assessment of work and outputs.

-Completion of the IPoW stakeholders' survey, compiling survey results and making them available on the website by the secretariat

(e) October 2016

-Consideration of the results of the Strategic Review of the IPoW 2014-2017 and results of the IPoW stakeholders' survey by the joint Bureaux,

-Presentation of the Strategic Review process, results of the stakeholders' survey by the secretariat at COFFI session in October 2016 for further inputs and discussion on the future programme

(f) November 2016

-First secretariat's draft of the new IPoW, after JB review, will be shared with member States and other stakeholders

-Organisation of a special workshop and discussion of the first draft of IPoW 2018-2021 with the participation of interested stakeholders and members of the Joint Bureau (21-22 November 2016).

Phase II: Preparation of the integrated programme of work 2018 - 2021

(g) January 2017

-First Joint Bureau draft of the 2018-2021 IPoW to be shared with member States and other stakeholders.

(h) May 2017

-Second Joint Bureau draft will be discussed with stakeholders at the Joint Working Party in May 2017 and afterwards by Joint Bureau for final review

(i) June / July 2017

- Final Joint Bureau draft of the IPoW 2018-2021 will be completed before the mid-July 2017.

(j) October 2017

Joint sessions of the COFFI and EFC finalize and adopt the new IPoW 2018-2021.

(k) January 2018

Implementation of the new integrated programme of work begins.

Introduction

The '2014-2017 Integrated Programmes of Work (IPoW) for the ECE Committee on Forests and the Forest Industry (COFFI) and the FAO European Forestry Commission (EFC)' provides the main framework for UNECE and FAO activities on sustainable forest management and the forest sector in the region. The IPoW was the result of the Strategic Review 2011-2012, which involved member States, interested organizations and other stakeholders. The IPoW was adopted by member States at the joint session of COFFI and EFC (Metsä2013), in Rovaniemi, Finland, on 9-13 December 2013.

The overall goal of the IPoW 2014-17³, is to "Support member countries and relevant stakeholders in their efforts to sustainably manage and use ECE-region forests so that they provide products and ecosystem services to benefit society". The overall goal is achieved by: providing the best available information; facilitating policy dialogue and communication; and building capacity.

The IPoW 2014-2017 covers the region (hereinafter called "the region") composed of fiftysix members States of the UNECE (COFFI members), of which thirty-nine and the European Union are also members of the EFC⁴. The Programme addresses sustainable forest management, the sound and legal use of forest products for raw material and energy, and forest services. The Programme makes reference to the Rovaniemi Action Plan for the Forest Sector in a Green Economy, which was also adopted at Metsä2013.

The IPoW 2014-2017 activities are structured around four work areas (WA):

- WA1: Data, monitoring and assessment;
- WA2: Policy dialogue and advice;
- WA3: Communication and outreach;
- WA4: Capacity-building.

The Joint ECE/FAO Working Party on Forest Statistics, Economics and Management is the subsidiary body to both COFFI and EFC. Its contribution to the implementation of the IPoW
