IRU external audit report and related matters

Note by the secretariat

I. Introduction

- 1. At its 146th session, the Working Party, in response to a proposal by the delegation of the Russian Federation, requested the secretariat to address a letter to the management of all national associations asking them (a) if they had been granted access to the external audit report of the International Road Transport Union (IRU) and (b) what their views were on the external audit report. The secretariat was requested to report the findings to the Working Party at its next session (see ECE/TRANS/WP.30/292, para. 35).
- 2. Further to this request, the secretariat addressed a letter to the associations on 6 July 2017 (by regular mail and email), quoting the two aforementioned questions and asking for replies by 21 July 2017 (see Annex).

II. Replies

- 3. To date (27 July 2017), the secretariat received 38 replies.
- 4. - 5. Out of the replies, twenty-six associations replied (a) that they had been granted access to the external audit report of IRU and (b) that the report had not led to any comments from their side, one association specifying that the report is still under consideration by its highest body.
- 6. A further ten associations replied along the same lines, but in a more extensive manner, clarifying that they had been informed about the results of the external audit at the IRU General Assembly of November 2016 and expressing their appreciation for the quality of the audit report and the way how the IRU Presidency and Secretariat is keeping national associations up to date about any follow-up actions. One association replied that feedback had been provided to IRU and, furthermore, that it considered the issue as an internal matter between IRU and its member association. Another association replied that, although access to the external audit report had been granted, the complexity and lack of transparency in the structures of IRU had complicated any sound judgement of its content.
- 7. Two associations, namely AITA from the Republic of Moldova and ARTRI from Romania, complained about the fact that, on 28 June 2017, IRU had addressed a letter to all associations, informing them of the questions by WP.30 and providing information, alluding, in their view, how associations were expected to reply.

III. Considerations by the Working Party

8. The Working Party is invited to take note of the aggregate outcome of the survey among national associations and provide guidance to the secretariat how it further wishes to pursue the matter.
