Note: The text reproduced below was prepared by the Expert from Italy in order to eliminate in annex 3, paragraph 3.1.2.4.2.1. the repetition of provisions of the new paragraph 3.1.2.4.2.4. of the same annex.
(Note by the secretariat: The corrigendum refers to document E/EC/324 E/ECE/TRANS/505/Rev.1/Add.50/Rev.1/Amend.1, where the text of paragraph 3.1.2.4.2.1. is consolidated, i.e. incorporates also the text which had been re-introduced by Corrigendum 2 to the 02 series of amendments to Regulation No. 51.)

## A. PROPOSAL

Annex 3,

Paragraph 3.1.2.4.2.1., amend to read (deleting the last two subparagraphs and the corresponding footnote $5 /$ ):
".... this down-shift may be avoided, at the manufacturer's choice, according to paragraph 3.1.2.4.2.4."

Paragraph 3.1.3., the reference to footnote 6/ and footnote 6/, renumber as footnote 5/.

## B. JUSTIFICATION

This corrigendum would align the test method of Regulation No. 51 with that of standard ISO 362:1998 (third edition, dated 15 June 1998). It would eliminate in annex 3 the repetition of provisions of new paragraph 3.1.2.4.2.4. in the text of paragraph 3.1.2.4.2.1. In practice this means deleting the text which had been re-introduced into paragraph 3.1.2.4.2.1. by Corrigendum 2 to the 02 series of amendments to Regulation No. 51.

Note by the secretariat: The reference to annex 3 and the renumbering of footnote 6/ were not mentioned in the proposal, as received from Italy.
