## A. PROPOSAL

Paragraph 5.3.1., amend to read:

".... differ by more than ± 2 per cent for rated net power and ...."

Paragraph 5.3.3., amend to read:

"5.3.3. Specific fuel consumption

The specific fuel consumption curve declared by the manufacturer ..."

Annex 5, paragraph 2.1., second alinea amend to read:

".... at rated speed. Under certain circumstances, the approval authority may conclude that the family can be best characterized by testing a second engine. Thus, the approval authority may select an additional engine for test."

Annex 6, paragraph 4.1., amend to read:

"4.1. Net power and specific fuel consumption of internal combustion engine

Measurements of the net power and specific fuel consumption shall be taken at the rated speed and the maximum torque speed as defined in paragraph 5 of this Regulation.

The values measured by the technical service for the engine sampled shall not differ by more than  $\pm$  5 per cent for the net power (torque), and  $\pm$  10 per cent for the specific fuel consumption with a tolerance of  $\pm$  5 per cent for engine speed."
