Addendum

At the fifty-second session of the Working Party on Inland Water Transport, the Contracting Parties to the European Agreement on Main Inland Waterways of International Importance (AGN), in accordance with the relevant provisions of Article 13 of the Agreement have unanimously agreed to adopt the proposed amendments to annexes I and II of the Agreement (ECE/TRANS/SC.3/181, para. 14).
