b. The NRMM GTR is based on 2 sources: US EPA Part 1065 and WHDC draft gtr, both including in different degrees and with deviations the ISO standards. The two sources reflect two approaches: type approval and self certification. Both sources have been used in a complementary manner.

### c. Progress of the gtr drafting

The first level draft was completed in occasion of the Ottawa meeting. It addressed various applications to supply the WG with a quite general reference platform. In Ottawa, the experts decided to proceed with the second level draft specifically addressed to NRMM diesel engines.
