#### 1. Adoption of the Agenda

#### 2. Identification of cargo flows on the Euro-Asian transport links

The Group of Experts may wish to recall that based on its adopted work plan (ECE/TRANS/WP.5/GE.2/2013/1) the Group should prepare an analysis of the Euro-Asian trade flows with the objective to identify possible cargo that could be transported by inland transport (road and rail).

The Group of Experts may wish to recall that at the previous session the secretariat was requested to prepare a questionnaire for approval for the main ports connected with the EATL routes. The Group of Experts may wish to consider and approve the questionnaire prepared (ECE/TRANS/WP.5/GE.2/2014/2).

As there are at least 20 ports with hinterland connections covered by the EATL project, the Group asked the secretariat to invite those ports to the Group's meetings. The Group of Experts may wish to consider the presentations by representatives of maritime ports on types of cargo flows that are being transported between Europe and Asia, their volume, frequency and possibly value.

# 3. Facilitating of the coordination of integrated time schedules and tariffs on the Euro-Asian transport links

The Group of Experts may wish to recall that based on its adopted work plan (ECE/TRANS/WP.5/GE.2/2013/1) it should work closely with EATL project member States, railways authorities, road transport associations and other relevant stakeholders on making Euro-Asian Transport Linkages operational by supporting the development of new rail and road transport services along selected Euro-Asian rail and road transport routes.

To achieve this objective, integrated tariffs and time schedules should be prepared for the rail and road routes already identified by the project. The secretariat should work closely with interested railway authorities and other stakeholders as to identify the ways that these integrated tariffs and time schedules should be created and agreed.

The Group of Experts may wish to recall that at the previous session requested the secretariat to prepare a template for time schedules and tariffs for all countries involved in the EATL routes for approval by the group (ECE/TRANS/WP.5/GE.2/2014/3). This template will be sent to the organizations for collection of all relevant data.

The Group of Experts will be informed by the participating Governments, international organizations and other stakeholders about the pertinent issues.

The secretariat will present to the Group of Experts a template for time schedules and tariffs for discussion and approval.

The Trans-European Railway (TER) project officer will brief the Group about relevant TER-related developments.

# 4. Identification of needs and requirements by producers, shippers, traders and freight forwarders in transport and trade on the EATL routes
