

2. Identification of cargo flows on the Euro-Asian transport links

The Group of Experts may wish to recall that at the previous session it kindly requested Professor John Liu to prepare a technical document with analysis and recommendations regarding Euro-Asian trade (Informal document No. 2).

The Group of Experts may also wish to recall that at the previous session it demanded secretariat to prepare a document (based on the approved questionnaire) with information about the commodity structure of Euro-Asian trade that goes through maritime ports (Informal document No. 3).

3. Facilitating of the coordination of integrated time schedules and tariffs on the Euro-Asian transport links

4. Identification of needs and requirements by producers, shippers, traders and freight forwarders in transport and trade on the EATL routes

The Group of Experts may wish to recall that based on adopted work plan (ECE/TRANS/WP.5/GE.2/2013/1) it ought to identify transportation needs and requirements (including obstacles) which face producers, shippers, traders and freight forwarders along nine rail and road EATL corridors.

The Group of Experts will consider a document (Informal document No. 5) on a comparative analysis of time and cost between rail and maritime transport between Europe and Asia. The document is kindly requested from company Plaske at the eleventh session of the Group.

The Group of Experts will consider the presentations by producers, shippers, traders and freight forwarders who will share their experience, best practices, problems and proposals for solutions.
