# 1. Adoption of the agenda

# 2. Regulation No. 107 (M<sub>2</sub> and M<sub>3</sub> vehicles)

#### (a) Proposals for further amendments

GRSG agreed to review ECE/TRANS/WP.29/GRSG/2014/6/Rev.1 proposed by Sweden to insert new test requirements for automatic fire suppression systems in the engine compartment of buses and coaches.

# 3. Regulation No. 39 (Speedometer)

GRSG agreed to resume consideration of an updated proposal by Belgium to insert new provisions on the installation of odometers (ECE/TRANS/WP.29/GRSG/2015/15). GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2015/16 proposing further amendments submitted by the Fédération Internationale de l'Automobile (FIA).

# 4. Regulation No. 43 (Safety glazing)

GRSG agreed to consider a proposal by European Association of Automotive Suppliers (CLEPA) excluding an area from the main vision zone to allow the application of safety systems for vehicles other than  $M_1$  category (ECE/TRANS/WP.29/GRSG/2015/3).

GRSG agreed to resume consideration of ECE/TRANS/WP.29/GRSG/2015/4 tabled by Hungary allowing the use of thick glass panes for multiple glazed units.

GRSG agreed to resume consideration of a proposal by the Republic of Korea to amend the methodology of the 227g ball drop test for toughened glass that would cope with defects of panoramic sunroofs, awaiting further proposals, if available.

# 5. Regulation No. 46 (Devices for indirect vision)

GRSG may wish to be informed by the Chair of the Informal Group on Camera Monitor Systems (IGCMS) about the progress made by the group during its recent informal meetings and to consider ECE/TRANS/WP.29/GRSG/2015/2 proposing amendments to UN Regulation No. 46 as well as a number of amendments to other UN Regulations Nos. 10, 26, 61, 79, 94, 107 and 125.

GRSG agreed to resume consideration of ECE/TRANS/WP.29/GRSG/2014/26 to increase the safety benefits of the driver's field of vision and the pedestrian safety in narrow streets on the basis of an updated proposal by Japan, if available.

GRSG agreed to consider an updated proposal by Germany proposing requirements for mirrors that have a folding mechanism operated electronically or by any other automatic system, if available.

# 6. Regulation No. 58 (Rear underrun protection)

GRSG agreed to continue consideration of a revised proposal by Germany introducing more stringent requirements for rear underrun protection devices.

#### 7. Regulation No. 67 (Equipment for Liquefied Petroleum Gas (LPG))

GRSG may wish to reconsider an updated proposal by the expert from the European Liquefied Petroleum Gas Association on new provisions for preventing a flow of LPG into the petrol or diesel tank, if available.

# 8. Regulation No. 97 (Vehicle Alarm Systems (VAS))

GRSG may wish to be informed about the position of the Working Party on Lighting and Light-Signalling on ECE/TRANS/WP.29/2015/36 aimed at removing additional vehicle lighting not in compliance with UN Regulation No. 48.

# 9. Regulation No. 110 (Specific components for CNG)

GRSG is expected to consider a revised proposal by Belgium on periodic inspections of pressure relief valves (ECE/TRANS/WP.29/GRSG/2014/28).

GRSG agreed to continue consideration of a revised proposal by the Netherlands to regulate the direction of discharging for the pressure relief devices of CNG containers (ECE/TRANS/WP.29/GRSG/2015/6).

GRSG may wish to consider a revised proposal tabled by the experts from the Netherlands and the International Association for Natural Gas Vehicles clarifying the provisions for manual and automatic valves (ECE/TRANS/WP.29/GRSG/2014/30).

GRSG may also wish to consider a set of draft amendments on the exterior protection of gas cylinders and on a proposal to align the provisions of Annex 3 to Regulation No. 110 with those of standard ISO 11439:2013, if available.

GRSG is expected to consider GRSG-108-02 proposing revised Terms of Reference (ToR) for an Informal Working Group to revise the provisions of Regulation No. 110.

GRSG agreed to resume discussion on the outcome of a "Study group for CNG cylinders" established in Japan for the investigation of safety related issues in Regulation No. 110, if available.

GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2015/5 and ECE/TRANS/WP.29/GRSG/2015/6, proposed by the Netherlands, correcting the provisions of Chapter 18 following the introduction of automatic valves and inserting a new series of amendments into the UN Regulation to regulate the direction of discharging of the CNG container, respectively.

# 10. Regulation No. 116 (Vehicle Alarm Systems)

GRSG is expected to consider proposals, if available, to insert new provisions on new innovative vehicle alarms systems such as silent alarm or door-unlocking, using smart phones.

GRSG may wish to consider ECE/TRANS/WP.29/GRSG/2015/7 proposed by the International Organization of Motor Vehicle Manufacturers allowing the introduction of different operating voltage ranges according to the battery technology.

Similarly to agenda item 8, GRSG may wish to be informed about the position of GRE on ECE/TRANS/WP.29/2015/37.

# 11. Regulation No. 118 (Burning behaviour)

# 15. Consolidated Resolution on the Construction of Vehicles (R.E.3)
