## Management of the Road Infrastructure

1. The Council of Ministers determines the state policy on planning, construction, administration and maintenance of the road infrastructure in the Republic of Bulgaria. The Council of Ministers:

Adopts a strategy for development of the road infrastructure and a mid-term operational programme for implementation of the strategy.

2. The Ministry of Transport, Informational Technology and Communications and the Ministry of Regional Development and Public Works:

- Implement the national policy for development and safety management of the road infrastructure;
- Propose to the Council of Ministers a strategy for development of the road infrastructure and med-term programme for its implementation;
- Introduce into the Council of Ministers draft legal and regulatory Acts governing the use and management of roads according to their competences.

### **Toll system**

### Indicative value – EUR 100 million

It is intended to introduce a toll for motor vehicles over 3.5 t and an electronic vignette for light motor vehicles up to 3.5 t

Expected annual revenue from the toll system – about EUR 400 - 500 million
