

## B. JUSTIFICATION

The modification of the title of the Regulation was discussed during the seventy-eighth session of GRSG with a view to aligning it with the title of Regulation No. 36. However, it was not adopted and was deemed to be appropriate.

The "alternative top part" which is described in the third subparagraph of paragraph 5.7.1.1. was not shown in figure 1 of annex 3, as referred to.
