


Background:

- Two quite separate regimes for carriage by rail after the Second World War
 - CIV & SMPS for passenger traffic
 - CIM & SMGS for freight traffic
 - Two organisational structures: OTIF OSShD
- Fundamental social changes in both East and West after 1989
- Extension of Western European economic and security structures to the East
- Consequences for the rail mode?



CIM and SMGS states











Customer requirements:

- Improvement in the CIM/SMGS interface
- Drawing up of a common CIM/SMGS consignment note
- Introduction on specific Trans-European corridors, e.g. Corridor II (Berlin – Moscow) or Corridor III (Dresden – Kiev)
- Both customers and railways have the same objectives!



Common CIM/SMGS consignment note (1)

CIT remit:

- Creation of a common CIM/SMGS
 consignment note which provides evidence of
 the existence of both contracts of carriage,
 and which is
- recognised as a customs and bank document which can be used without restriction in the customs territories in question, and which
- does not compromise the liability provisions.



Common CIM/SMGS consignment note (2)

- A combination of the existing CIM and SMGS consignment notes
- Further criterion: UNECE Layout Key for trade documents
- Front: common CIM/SMGS fields and CIM fields
- Back: SMGS fields
- 1 = consignor & customs fields
- (39) = railway fields

Appendix 2: Explanatory notes on the content of the common CIM/SMGS consignment note

- Explanation of each data item in the numerical order of the fields
- For each data item
 - Field number
 - Status
 - Contract of carriage (CIM/SMGS, CIM, SMGS)
 - Definition



A. General provisions:

- Within the CIM area: a manual
- Within the SMGS area: an appendix to the SMGS
- Scope:
 - traffic between CIT and SMGS members who are specified in Appendix 1
 - consignments subject to the CIM Uniform Rules and the SMGS and which are handed over for carriage with a common CIM/SMGS consignment note
 - at the CIM/SMGS interface, consignments remain the responsibility of the carrier or substitute carrier



B. Common provisions (1)

- Legal basis Article 6 § 8 CIM and Article 7 SMGS
- Appendix 2 contains the explanatory notes
- Languages: RU (SMGS) / DE, FR or EN (CIM)
- Parties to the contract:
 - CIM → SMGS traffic: consignor of the first contract of carriage (CIM) is also the consignee of the first contract and the consignor of the second (SMGS) contract of carriage
 - SMGS→ CIM traffic: consignor of the first contract of carriage (SMGS) is also the consignee of the first contract and the consignor of the second (CIM) contract of carriage



B. Common provisions (2)

- Payment of charges
 - CIM → SMGS traffic: in the CIM area in principle by the consignor; in the SMGS area in principle by the consignee or the payers of transit charges
 - SMGS → CIM traffic: in the SMGS area, by the consignor for the first railway otherwise by the payers of transit charges; in the CIM area by the consignee
- Liability, formal report
- Seals (approval, sealing process, details on the consignment note)
- Authority to consign
- Dangerous goods (RID / SMGS Appendix 2)
- Labelling of the goods
- Loading tackle



C. Paper common CIM/SMGS consignment note

- Specimen:
 - Appendix 5 to the manual
 - Combination of the CIM & SMGS consignment notes
 - 6 sheets
- Additional copy of the invoice:
 - for SMGS → CIM traffic: made out by the consignor
 - for CIM → SMGS traffic: made out by the SMGS railway at the CIM/SMGS interface (photocopy of the invoice authenticated with a stamp)



D. Electronic common CIM/SMGS consignment note

- Legal basis for the electronic exchange of consignment note data:
 - Article 6 § 9 CIM: based on functional equivalence
 - Article 7 § 14 SMGS: based on an agreement between the carrier and the customer
- The following provisions are still being worked on:
 - Transmission of messages
 - Content of messages / specifications
