A. PROJECTS TO BE IMPLEMENTED IN 2014-2015, DEVELOPED SPECIALLY FOR SPECA COUNTRIES ONLY AND ARE EITHER FULLY FUNDED OR THEIR FUNDING IS FORTHCOMING IN 2014

WATER, ENERGY AND ENVIRONMENT

In light of a large degree of interdependence of most of the SPECA countries, efficient use of water and energy resources on mutually agreed and beneficial terms is critical for economic and social development in the region and meeting basic human needs of its populations. The theme of Water and Energy was among the initial work areas of SPECA and is addressed through the Project Working Group on Water and Energy Resources. Earlier work has resulted in the elaboration of the Strategy for the Rational and Efficient Use of Water and Energy Resources in Central Asia (http://www.unece.org/fileadmin/DAM/SPECA/documents/wer/effuse_e.pdf).

Ongoing projects contribute to the implementation of the SPECA Strategy as well as being part of the Work Programme of the UNECE Water Convention. Work is ongoing on regional cooperation on water management including on water quality and dam safety. Bilateral cooperation between Kazakhstan and Kyrgyzstan on the Chu and Talas rivers as well as between Afghanistan and Tajikistan on hydrology and environment on the Pyanj river are part of the work programme.

The Programme "Transboundary Water Management in Central Asia" was launched in 2008 by the Government of Germany. A Programme component "Regional dialogue and cooperation on water resources management" is being implemented by the UNECE. In a second project phase work continues on regional institutions and to raise the capacity to apply international water law in the region.

Activities under the UNECE Sustainable Energy Work Programme in the region are also contributing to the implementation of the SPECA Strategy. They include work on renewable energy development, financing energy efficiency for climate change mitigation, energy efficiency market formation and support to energy efficiency capacity-building, as well as climate change mitigation through attracting foreign direct investment in advanced fossil fuel technologies.

In 2010, UNECE and ESCAP jointly initiated the annual forum on sustainable energy development for countries of Central Asia and neighbouring regions aimed to provide a platform for governments, energy experts, international organisations, and financial institutions to discuss the emerging global and regional energy issues and to share good practiced on implementing

sustainable energy policies and projects. Since 2010 these forums have been successfully held in Kazakhstan (2010), Tajikistan (2011), Kyrgyzstan (2012) and Georgia (2013). Annual forum organized by UNECE, ESCAP and regional partners has become an important platform for discussing energy and sustainable development in the European and Asian regions including SPECA region.

Next forum will be convened in 2014.

In May 2013, ESCAP convened the first Asian and Pacific Energy Forum (APEF) in Vladivostok, Russian Federation. This first United Nations ministerial conference on energy in Asia-Pacific adopted two outcome documents, namely: (a) the Ministerial Declaration on Regional Cooperation for Enhanced Energy Security and the Sustainable Use of Energy in Asia and the Pacific: Shaping the Future of Sustainable Energy in Asia; the Pacific; and (b) the Plan of Action on Regional Cooperation for Enhanced Energy Security and the Sustainable Use of Energy in Asia and the Pacific, 2014-2018. The APEF Plan of Action has identified 15 priority areas for energy cooperation in Asia-Pacific that will also serve as a basis for ESCAP energy related activities in SPECA region in 2014-2015.

TRANSPORT

The annual sessions of the Project Working Group on Transport and Border Crossing serve as an effective cooperation mechanism to address the specific problems of transit transport from, in and through SPECA countries. Improvement of international transit transport infrastructure and services, as recognized in the Almaty Programme of Action, will facilitate further integration of SPECA countries into the world economy. The support for the Almaty Programme of Action was reiterated in ESCAP resolution 63/9 and 68/4 through the implementation of the Regional Action Programme for Transport Development in Asia and the Pacific, phase I (2007-2011) and phase II (2012-2016) for the benefit of landlocked and transit developing countries.

The 18th session of the SPECA Project Working Group on Transport and Border Crossing (PWG-TBC) was held on 2-3 May 2013 in Almaty, Kazakhstan. It adopted its Programme of Work for 2014-2015, which includes: organization of regular sessions of the SPECA PWG and bilateral consultations on border-crossing issues between SPECA countries; implementation of sub regional projects of common interest to SPECA countries and development of SPECA Transport databases, identification and isolation of bottlenecks, establishment / strengthening of national facilitation and coordinating mechanisms, enhancement of legal frameworks for transport facilitation and accession to multilateral agreements, investment promotion, making operational of transport corridors, simplification/harmonization of border-crossing procedures, including through ICT, and road safety issues.

TRADE DEVELOPMENT

At its seventh session, which took place in Bangkok on 26 November 2012, the SPECA Project Working Group on Trade (PWG on Trade) adopted revised Terms of Reference (ToR) and Work Plan. The main focus remained on trade facilitation and trade policy, notably in the development of the SPECA Aid-for-Trade initiative, regulatory cooperation and harmonization, and assistance to the implementation of agricultural quality standards. New areas, including trade and investment promotion, assistance to the sustainable timber and housing sectors were added. Building synergies

with various development partners, such as UNDP, the Eurasian Economic Commission, CAREC, the Islamic Development Bank, OSCE, and other agencies are a priority.

STATISTICAL CAPACITY-BUILDING

Official statistics are essential tools for evidence-based policy making, ensuring transparency and accountability in the process of economic, social and environmental reforms and enabling decision makers to formulate policies and to monitor and evaluate their deliveries.

Over the last 20 years, SPECA countries were confronted with the necessity, but also with the opportunity, for a rapid and complete transformation of their national statistical systems. Although official statistics in these countries have developed considerably, the broadening of the scope of traditional statistical measures to include emerging users' needs for integrated social, demographic,

economic and environmental will require further improvement of their organizational and technical capacities to collect, process and disseminate official statistics.

This will be achieved by promoting the exchange at subregional level of national good practices, undertaking benchmark studies and stimulating the establishment of an active network of experts. Advisory missions and training workshops will be conducted in response to specific request for assistance to improve the statistical capacity of SPECA countries in all relevant statistical areas, such as economic and business statistics, demographic and social statistics, gender statistics, migration statistics, environmental-economic accounting with major focus on water and energy accounts, and sustainable development indicators (Rio +20 initiative and post-2015 strategy).

The activities under the SPECA PWG on Statistics will strongly rely on findings and recommendations provided in recent global assessments reports of national statistical systems conducted jointly by the UNECE, Eurostat and EFTA. One of the major expected accomplishments is that countries systematically integrate these recommendations into their National Strategies for the Development of Statistics (NSDS) developed by the World Bank (WB), jointly with national statistical authorities and the UNECE. NSDS will serve as a framework for international and bilateral assistance and will be used to mobilise resources from various multilateral and bilateral partners, including the WB Trust Fund for Statistical Capacity Building (WB-TFSCB).

The major expected accomplishments of the 2014-2015 SPECA statistical programme of work will be to improve the efficiency of the statistical production, increase the coverage and accuracy of statistical indicators, and enhance the capacity to disseminate statistical information using modern web-based technologies and software.

Regular UNECE resources will be complement by the DA resources, as well as extrabudgetary funds. To ensure the effective delivery of its technical cooperation activities, the SPECA programme of work in statistics will continue to forge partnerships with major international and bilateral partners in the subregion, in particular with the World Bank, CIS-STAT, Eurostat, EFTA, OECD, UNFPA, UNICEF, UNDP, ILO and the IMF.

Recently, ESCAP mentioned its willingness in the future to participate in SPECA activities related to statistics. UNECE welcomes the full participation of ESCAP in statistical activities that indeed would enhance the effectiveness of the programme, improve synergies and allow Afghanistan to participate fully in the activities of the SPECA PWG on Statistics.

GENDER AND ECONOMY

SPECA Working Group on Gender and Economy

The proposed Work Plan for 2014-2015 will continue the efforts of the SPECA Working Group on Gender and Economy to promote the mainstreaming of gender in economic policies and provide further support for capacity-building, The 2014-2015 Work Plan also involves contributing to the review of progress in implementation of the Beijing Platform for Action, the outcome of which will feed into the global review to be conducted by the United Nations Commission on the Status of Women at its 59th session in 2015.

Capacity-building

Building on the successful cooperation with the Centre for International Cooperation of the Ministry of Foreign Affairs of Israel and the Golda Meir Mount Carmel International Training Centre, training workshops in support of women's entrepreneurship in Central Asia are planned for 2014 and 2015.

A key activity for the Working Group in 2014 and 2015 is securing funds for the two project proposals discussed and approved during the meeting of the WG on 15 November 2012.

Beijing+20 review process

Within the global review of progress in implementation of the Beijing Platform for Action, UNECE and ESCAP will coordinate the review process within their respective regions. The SPECA WG will support the countries in Central Asia in undertaking their national-level reviews. National women's machineries and line ministries will be engaged in the review process at the national level, as well as in the UNECE and ESCAP regions.

Fundraising for new project activities

The 2014-2015 Work Plan includes resource mobilization which, if successful, would be followed by implementation of two projects.

The proposed project "Strengthening institutional support for women entrepreneurs through business associations in SPECA countries" would contribute to strengthening enabling business environments for women entrepreneurs in the SPECA region through capacity-building and networking. The project activities comprise four subregional training workshops for women business associations in the SPECA region. The workshops would strengthen the capacity of women's business associations to (1) advocate the needs of business women to policymakers, and (2) provide business training and support services to women entrepreneurs in their respective countries.

The proposed project "Enhancing the capacity of governments in Central Asia and the South Caucasus to mainstream gender in economic policies" involves provision of tailored gender training to economic policymakers. In order to achieve gender-responsive economic policies, it is important to integrate gender into existing training curricula for policymakers on a permanent basis. The proposed project would address this challenge in three steps: by developing a training module which is tailored to the practical needs of economic policymakers; by delivering training to government trainers to use the module, who would then, in a third step, train economic policymakers to formulate and implement gender-sensitive policies.
