- How to improve incentives, and what are the barriers to be overcome,

- Co-development of services with citizens and users,
- What role for public-private partnerships in the delivery of public services,
- To what extent innovative social entrepreneurship can complement or replace public services,
- Case studies and best practices in different areas.


