1. Preamble

The current practice of the exchange of business documents by means of telecommunications – usually defined as e-Business presents a major opportunity to improve the competitiveness of companies, especially for Small and Medium Enterprises (SME).

The commercial invoice is an important document exchanged between trading partners. In addition to its prime function as a request for payment from the seller to the buyer, the invoice is an important accounting document and, also has potential legal implications for both trading partners. Additionally, e.g., in the member states of the European Union, the invoice is the key document for VAT declaration and reclamation, for statistics declaration, and to support export and import declaration in respect of trade with other countries.

Started as an initiative by CEN/ISSS Work shop eBES, the European Expert Group 1 (EEG1) – Supply Chain & e-Procurement developed the Cross Industry Invoice in 2004. The Cross Industry Invoice has been compiled using the EUROFER ESIDEL version 1.0 as the base, with contributions and submissions from: EUROFER, GS1, CIDX, EDIFICE, AIAG/ODETTE/JAMA, GHX and EDS. The first draft of the Business Requirements Specification (BRS) was presented at the September 2004 UN/CEFACT Forum to the TBG1 members for review and comments from the other regions. In 2008 version 2.0 of the BRS document was released. Version 2.0 of the BRS was taken as the basis to develop the Requirements Specification Mapping (RSM) version 2.00 and 2.01.

The structure of this document is based on the structure of the UN/CEFACT Requirements Specification Mapping (RSM) – Documentation Template Guidelines.



Philosophy behind the conceptual design

The conceptual design is based on the assumption that information exchanged in the order-to-pay process tends to have a large degree of similarity. Therefore rather than linking the information to message specific entities three neutral entities have been defined: Trade Agreement, Trade Delivery and Trade Settlement. These entities contain the main semantic payload for all communication exchanges, on header as well as on line level.

A fourth essential entity is the Product entity. This entity holds all characteristics of the trade product that are independent of a particular trade transaction.

The Trade Transaction and Trade Line Item entities serve to structure the entities mentioned before.

Description of the main entities

- Document Context: Application processing information for the business document.
- Document Heading: Generic document heading information such as Invoice number, Issue date.
- Trade Transaction: Information on the trade transaction(s) to which the invoice applies.
- Trade Line Item: Information on the line items that are being invoiced.
- Trade Agreement: information on the commercial agreement on which the invoiced trade transaction or line is based.
- Trade Delivery: information on the fulfilment of the invoiced trade transaction or line.
- Trade Settlement: information on the financial settlement of the invoiced trade transaction or line.
- Product: Information on the generic object that is being invoiced.
- Product Instance: Information on the individual objects that are being invoiced.
- Valuation Breakdown Statement: Used for describing, asserting or approving the works performed and invoiced in specific sectors.
