3. Plenary Session *Energy for development – the new normal*

Truly transforming the energy system will require creative, innovative and transformative shifts in policy and regulation. Certain options for improving the overall performance of today's energy system often are excluded for reasons of public perception and emotions, politics, imposed market distortions, or environmental and safety concerns. In many countries, the current political, regulatory, and industrial infrastructure is not yet ready for a deep and accelerated transformation of aging infrastructure or countries are not yet prepared to address the many challenges that will emerge in the coming decade as new entrants and emerging business models are distorting old paradigms and are shifting geopolitical powers. Yet, this accelerated impact on systems is the new normal in energy. This session will offer the opportunity to deliberate emerging opportunities and concerns deriving from the implications of the “new normal” in energy.

4. Plenary Session *Let's talk about the elephant*

The development and deployment of clean technologies and their interplay with existing infrastructure lie at the heart of options that are available to build the future energy system over the medium and long term, especially as 80% of today's energy is fossil-based. This discussion will examine energy infrastructure, resilience and planning, and proposes to provide a platform to explore various angles. Participants will be asked to provide perspectives about the necessary paradigm shift for informed policy and development planning, referring to fossil fuels. The adequate integration of innovation, new business models and technologies requires a change in mindset away from conventional behaviour and practices to an integrated framework approach that brings together climate information, climate impact assessment and decision-making for investment, but that also takes a generational view across society.
