Introduction

The purpose of the session is to allow for an in-depth presentation and discussion of activities related to emission inventories of air pollutants. The session is going to be held in the form of a technical workshop, with presentations provided by representatives of TFEIP, CEIP and other EMEP groups and centres. The presentations will deal with issues of such as inventory latest methodological developments, spatial and temporal resolution, uncertainties, completeness, current and future needs and policy relevance.

Expected outcome

The Steering Body is expected to discuss emission issued and come up with recommendations for future emission related work.

The representatives of the MSC-W in collaboration with MSC-E, CCC, CEIP, CIAM, Working Group on Effects, TFEIP, Task Force on Measurement and Modelling (TFMM) and Task Force on Integrated Assessment Modelling (TFIAM), will present the proposal for changing the EMEP domain and its spatial resolution. A draft paper outlining the proposal was presented at the recent meetings of the Bureau of the Steering Body and TFMM. The purpose of the session is to allow for an in-depth presentation and discussion of various aspects of the EMEP domain and its spatial resolution.

Expected outcome

The Steering Body is expected to consider the issue and approve respective recommendations to be adopted by the Executive Body at its thirty-first session.

Introduction

The four status reports listed above that are relevant for the evaluation of the progress in work in 2012 will be available on the EMEP website (www.emep.int). Under this sub-item, representatives of the EMEP task forces and centres will report on progress on measurements and modelling activities as outlined below:

- (a) The Co-Chairs of the Task Force on Measurements and Modelling will report on progress, including the results of the thirteenth meeting of the Task Force (Gozo, Malta, 17–19 April 2012);
- (b) Meteorological Synthesizing Centre-West (MSC-W) will give an overview of the activities on monitoring and modelling of acidification, eutrophication and photo-oxidants, including progress made by the Chemical Coordinating Centre (CCC), the Centre for Integrated Assessment Modelling (CIAM), its own work, discussions within the Task Force on Measurements and Modelling and plans for future work;
- (c) Meteorological Synthesizing Centre-East (MSC-E) will present an overview of the activities on monitoring and modelling of heavy metals, progress by CCC, its own work, discussions within the Task Force on Measurements and Modelling and plans for future work;
- (d) CCC will present an overview of activities on atmospheric monitoring and modelling of particulate matter (PM), including with respect to work at MSC-W and CIAM, its own work, the results of the Task Force on Measurements and Modelling and plans for work up to 2013;
- (e) MSC-E will present an overview of activities on monitoring and modelling of persistent organic pollutants, including with respect to work at CCC, its own work, the results of the Task Force on Measurements and Modelling and plans for future work.

Expected outcome

The Steering Body is expected: (a) to approve the executive summaries of the status reports and to decide to present them to the Executive Body; (b) to discuss the status of

implementation of the monitoring strategy; (c) to discuss progress made with respect to cooperation with national experts and provide guidance on means for its improvement; (d) to discuss progress made in modelling and monitoring activities in 2012 in all the above areas of work and to provide guidance on the further development of that work; and (e) to provide guidance on the further development of the measurement and modelling work.

(b) Integrated assessment modelling

The Chair of the Task Force on Integrated Assessment Modelling (TFIAM) will report on progress made, including the results of the forty-first meeting held in Bilthoven, the Netherlands (7-9 May 2012). CIAM will report on progress made, including the status of the GAINS model and the impacts of the revised Gothenburg Protocol.

Expected outcome

The Steering Body is expected to discuss progress made and to provide further guidance on the integrated assessment modelling work.

(c) Emissions

Introduction

The Chair of the Task Force on Emission Inventories and Projections will report on progress made, including the results of the Task Force's twenty-fifth meeting and thirteenth joint meeting with the European Environment Agency's (EEA) European Environment Information and Observation Network (EIONET) (Bern, Switzerland, 14-15 May 2012).

At this year's meeting the Task Force concentrated on the following four issues: quality of recently reported national data, technical support for those follow-up actions which are required following the revision of the Gothenburg Protocol, the proposal to change the EMEP grid, discussions on the European Union-funded project to update the EMEP/EEA Air Pollutant Emissions Inventory Guidebook. The TFEIP meeting was held back-to-back with a technical workshop on persistent organic pollutants (POPs).

CEIP will inform the Steering Body about the status of emissions data reporting, its own work and the work of CIAM on data quality. It will report on progress in the inventory improvement programme, in particular as regards the stage 3 in-depth reviews of the emission inventories.

Expected outcome

The Steering Body is expected to discuss progress made and to provide guidance on the emissions work.

(d) Hemispheric air pollution

Tentative timing: Tuesday, 18 September, 5 p.m.

Introduction:

The Co-Chairs of the Task Force on Hemispheric Transport of Air Pollution will report on: the results of its recent meeting (Pasadena, California, the US,1-3 February 2012). The TF meeting was held in conjunction with a workshop of the Atmospheric Chemistry & Climate Model Intercomparison Project (ACCMIP), at the same place on 30 January - 1 February 2012.

Expected outcome

The Steering Body is expected to discuss and approve the main findings of the Task Force and to provide guidance on the hemispheric transport of air pollution work.
