To Chief Inspector,

The Teritorial Hunting and Forestry Inspectorates have the obligation to carry out public consultations, within the application for the permanent removal or temporary occupation of land from the national forestry fund, according to Ministerial Order 25/2009.

The public consultation will be carried out by publishing on the inspectorate's website and by sending a letter to the local public authorities within the radius of the lands in question, of an announcement in which the following data will be given: the beneficiary's name, the name of the land owner, the surface of the land, the name of the objective, the duration (in case of temporary occupation of land), any other data deemed necessary to be available to the public, taking into consideration the type of the objective.

The period for public consultation is 5 calendar days from the date of submission of the announcement to the local public authority.

In case the request of the beneficiary meets the conditions to be promoted/approved, the submission of the announcement to the local public authority will be made within maximum 10 days from the date of the submission of the request for permanent removal/temporary occupation of the land from the national forestry fund (or from the date on which the last supplement was submitted by the beneficiary) to the Territorial Hunting and Forestry Inspectorate.
