INFORMATION

Concerning the admissibility reference of ACC/C/2016/140

Mining activities of lignite quarries surface is functioning in the period 1960-1970 in mining areas which were investigated and confirmed exploitable reserves of lignite. During 2002-2003, based on the Mining Law 85/2003, all lignite quarries requested license lignite surface mining perimeters outlined on the basis of documentation accompanied by:

- a) feasibility study of mineral resources and deposit protection, which will include initial termination activity plan, drawn up in accordance with the norms issued by the competent authority;
- b) exploitation development plan, drawn up in accordance with the technical instructions issued by the competent authority;
- c) environmental impact assessment study and environmental balance for the activity, as appropriate, drawn up under the law;
- d) environmental rehabilitation plan and technical project, prepared in accordance with the technical instructions issued by the competent authority;
- e) social impact assessment study and social mitigation plan in accordance with the technical instructions issued by the competent authority in the field of labor and social solidarity together with the ministry resort.

All these procedures were conducted according to the law at that time and land use was carried out in stages.

For continuing the extraction of lignite in perimeters of owning operating licenses during 2002-2003, Oltenia Energy Complex S.A. requested environmental agreements for the 10 perimeters, respectively Pinoasa, Tismana I, II Tismana, Rosia, Pesteană North, South Pesteană, red wolf Jilt Jilt North and South. For all these careers was walking on the environmental impact assessment procedure stipulated by GD 445/2009 and Ministry Order 135/2010 transposing Directive 2011/92 / EU on the assessment of the effects of certain public and private projects on the environment.
