Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by the Republic of Moldova with regard to access to information held by the State Hydrometeorological Service (ACCC/C/2017/147)

On 9 July 2017, the secretariat of the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) received from you the above communication addressed to the Compliance Committee of the Convention. The communication concerns compliance by the Republic of Moldova with the provisions of the Convention in connection with its alleged failure to provide access to information held by the State Hydrometeorological Service in a manner that would comply with the requirements of the Convention. The communication was submitted in accordance with the provisions of chapter VI of the annex to decision I/7 of the Meeting of the Parties.

Please note, however, that the Committee has not reached any conclusions with respect to the compliance issues referred to in the communication.
