After having analyzed this request it is considered that the interests and rights of the company owning the mining concessions, Galicia Tin & Tungsten S.L., may be affected. Because of this, we have issued a notice to the company under article 27 of Act 1/2016, of 18th of January, of transparency and good governance, article 19 of Act 19/2013, of 9th of December, on transparency, access to public information, and good governance, suspending the processing time of the aforementioned request for a period of 15 days or until the affected person registers its pleadings.

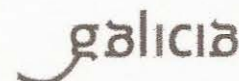

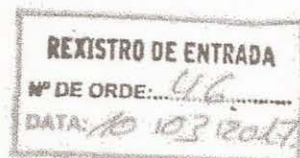
