# II. Annotations

The Task Force on Public Participation in Decision-Making was established, and its mandate laid down, by the Meeting of the Parties to the Convention at its resumed second extra-ordinary session (30 June 2010) (ECE/MP.PP/2010/2/Add.1, decision EMP.II/1).<sup>2</sup> The mandate was further extended by the Meeting of the Parties to the Convention through decision V/2 (ECE/MP.PP/2014/2/Add.1) adopted at its fifth session (Maastricht, the Netherlands, 30 June and 1 July 2014).<sup>3</sup> Decision V/2 sets out the issues to be addressed by the Task Force at paragraph 11.

The present meeting aims to discuss the main obstacles to effective public participation, exchange good practices to address those obstacles in relation to public participation in decision-making related to changes to or extensions of existing activities and public participation in decision-making in a transboundary context; share experiences linked to the implementation of the Maastricht Recommendations on Promoting Effective Public Participation in Decision-making in Environmental Matters (ECE/MP.PP/2014/2/Add.2); and convey a thematic session on decision-making for sustainable development.

The Task Force continues its work based on the outputs delivered at its previous meetings. The background material for the meeting will include relevant information derived from the 2014 national implementation reports, the Synthesis report on the status of implementation of the Convention, the Aarhus Convention Implementation Guide, the Maastricht recommendations on promoting effective public participation in decision-making in environmental matters, and relevant Compliance Committee findings of a systemic nature.

Participants will be invited to consider a number of issues in the specific context of (a) and (b), namely early public participation when all options are open; the availability of all relevant documents in the required languages to the public; effective notification and time frames for public participation; ensuring greater account is taken of the comments from the public in the final decisions and the provision of feedback on how the public's comments have been taken into account in the decisions. The session also aims to exchange good practices on the subject matter and to identify further needs in relation to the subjects.
