## **GENERAL COMMENTS**

- THE STRATEGY IS NOW QUITE WELL FORMULATED
- BACKGROUND SITUATION IS ANALYZED WELL
- GOOD PAPER FOR FURTHER DEVELOPMENT AND DISCUSSION INSIDE THE COUNTRY
- ALSO THE CONNECTION OF THE STRATEGY AND DEVELOPMENT OF LEGISLATION IS WELL UNDERSTOOD
- INCLUDING WELL FORMULATED INDICATORS TO THE IMPLEMENTATION PROCESS OF THE STRATEGY IS GOOD
- THE DEVELOPMENT OF STRATEGY IS ULTIMATELY A FOREVER CONTINUING PROCESS WHICH SHOULD BE EMPHASIZED



# **SOME DETAILED COMMENTS**

- IN RIVERINE ENVIRONMENTS THE FLOW PATTERN IS REALLY IMPORTANT. ALSO THE LOW-FLOW SITUATION IS CRITICAL, ESPECIALLY FOR THE ENVIRONMENT. IN THE STRATEGY MOSTLY FLOOD HAS BEEN TACKLED.
- WATERS ARE POLLUTED OUTSIDE OF THE COUNTRY BUT ALSO INSIDE OF THE COUNTRY, SO THE DOMESTIC WASTE WATER PURIFICATION ACTIVITIES ARE ALSO VERY IMPORTANT.



### **SOME DETAILED COMMENTS cont.1**

- uneven spatial and seasonal distribution of water resources
- the lakes and rivers are heavily polluted with both organic and inorganic substances (municipalities and industry)
- in the lowlands groundwater often has a high salt content
- majority of the population does not have reliable access to safe drinking water
- leaking sewers and transmission lines and only about 3 per cent of the discharged water is treated
- water losses in agriculture mainly because of inefficient and poorly maintained irrigation systems
- floods and sedimentation of rivers
- trans-boundary pollution
- water constructions and River Systems regulations environmental effects
- dam safety questions
- a decrease of 15% of both run-off and groundwater recharge is expected within the next 50 years due to the predicted increase of air temperature by 3 °C to 4 °C
- poor water ecological conditions in rivers



### **SOME DETAILED COMMENTS cont.2**

- GOOD TRANS-BOUNDARY WATER COOPERATION IS ESSENTIAL. COULD IT BE POSSIBLE TO ESTABLISH A COMMON TRANSBOUNDARY WATER COMMISSION. THERE ARE MANY GOOD EXAMPLES IN THE WORLD
- WHEN DEVELOPING THE IMPLEMENTATION PLAN A MORE DETAILED PRIORITIZATION SHOULD BE CREATED
- THE DEVELOPMENT OF STANDARDS AND LEGISLATION SHOULD BE BALANCED WITH THE PRIORITIZATION AND REALISTIC POSSIBILITIES OF THE SOCIETY
- HARMONIZATION WITH THE EU-LEGISLATION AND IMPLEMENTATION OF THE DIRECTIVES SHOULD BE A LONG-TERM GOAL



### **FINAL COMMENT**

- ADAPTATION OF EU WATER RELATED LEGISLATION AND DIRECTIVES AS SUCH IS NOT POSSIBLE IN AZERBAIJAN. THE GOALS ARE GOOD BUT IMPLEMENTATION TAKES LONG TIME
- IMPLEMENTATION OF WATER POLICY SHOULD ALWAYS BE RELATED TO THE SITUATION IN THE COUNTRY AND SOCIETY!
