Draft programme of work for 2014-2015 of the housing and land management component of the Housing, Land Management and Population subprogramme

Note by the secretariat

I. Introduction

1. The present document sets out the draft programme of work of the housing and land management component of the Housing, Land Management and Population subprogramme (“the subprogramme”) for 2014–2015. The Committee on Housing and Land Management (“the Committee”) is invited to consider the programme and subsequently adopt it at its seventy-fourth session. It will then be submitted to the Economic Commission for Europe (ECE) Executive Committee for formal approval. The Committee will have the opportunity to adjust its programme of work during the course of the biennium and such adjustments will be reflected in a separate document.
2. The draft programme of work applies a results-based approach. It comprises, for each cluster of activities, an expected accomplishment and a list of outputs/activities proposed to be carried out in 2014–2015. The delivery of these outputs/activities is expected to contribute to achieving the expected results.
3. The grouping of activities into clusters is the same as that used by the Committee for the biennial evaluation of its subprogramme performance. The correlation between the ECE Strategic Framework and the cluster framework used for subprogramme biennial evaluation for 2014–2015 is shown in document ECE/HBP/2013/11.
4. Furthermore, the outputs/activities listed in this document correspond with the ECE proposed programme budget for 2014–2015 and are complemented by additional items to reflect the more recent developments and identified needs of ECE member States. For easy reference, such new outputs/activities have been clearly indicated as “additional”.

5. The outputs/activities have been listed under the cluster of activities to which they belong according to the following main categories: (a) meetings and related parliamentary documentation; (b) publications and other information material; and (c) technical cooperation, including, seminars, workshops, training sessions, advisory services.
6. The relevant indicators of achievement, together with baseline and target data, against which performance will be measured, are presented in document ECE/HBP/2013/11 in order to facilitate the task of the Committee of assessing whether all outputs which are necessary to achieve the expected result have been included in the plan.
7. Section II comprises four clusters of activities as follows: sustainable housing and real estate markets; sustainable urban development; land administration and management; county profiles on housing and land management. The description of the clusters is based on the decisions taken at the seventy-third session of the Committee (ECE/HBP/170) and on the outcomes of a survey report, which highlights the priorities of ECE member States relevant to each cluster of the programme of work (ECE/HBP/2013/2).
8. The annex to the present document lists the ECE overall legislative mandates and those specific for the subprogramme.

II. Objective and strategy

9. The objective of the housing and land management component of the subprogramme is to improve the housing, urban and land governance in the region by strengthening the formulation and implementation of policies, enhancing social cohesion and developing capacities at the national and local levels.
10. The responsibility for the housing and land management component of the subprogramme is vested in the Trade and Sustainable Land Management Division.
11. The housing and land management component of the subprogramme works to improve housing, as well as urban and land governance, in the region. It also promotes the implementation of (a) the ECE strategy for a sustainable quality of life in human settlements in the twenty-first century, and (b) the Ministerial Declaration on Social and Economic Challenges in Distressed Urban Areas in the ECE Region. To achieve the expected results, the subprogramme will provide a forum for policy dialogue and exchange of experience, develop policy guidance and organize capacity-building activities in the areas of housing and land management to promote the implementation of ECE guidance and policy recommendations. This work will focus on: housing policy formulation and implementation; sustainable, energy-efficient housing; effective maintenance and management of the housing stock; increasing transparency in real estate markets; effective land administration; and spatial planning.
12. In order to contribute to the efficient and transparent governance and improvement of the urban environment, continued efforts will be made to analyse and review the existing housing situation, including maintenance, renewal and new construction, energy efficiency measures and safety in buildings, legislation and housing finance. This process will lead to the development of policy recommendations and related capacity-building activities.
13. The housing and land management component of the subprogramme will also promote the implementation of ECE guidance in the areas of: housing, including affordable and energy-efficient housing; informal settlements; climate neutral urban development; and transparent real estate markets. In the area of land management, emphasis will be placed on the upgrading of land and real estate systems in order to: provide secure ownership of land; ensure other private and public rights in real estate; and encourage investment. These

objectives will be promoted through capacity-building activities, while regional model programmes and pilot projects, as well as public-private partnerships, will be encouraged.

14. The integration of housing policy with spatial planning, land administration, population and environmental policy will be promoted through policy recommendations and related capacity-building activities, with a special emphasis on such cross-sectoral issues as urban response to climate change, energy efficiency in the housing sector and the housing needs of low-income segments of society.

| <p>This cluster focuses on improving housing energy efficiency, facilitating the maintenance, management and refurbishment of existing housing stock and developing real estate markets which contribute to economic growth. It also focuses on the social dimension of sustainable housing to address housing affordability, social housing and low-cost housing. The activity provides an opportunity to look at how to adapt the housing supply to demographic changes and ensure access to healthy and safe housing in the region. The cluster also covers the negotiations of a framework convention on sustainable housing in the ECE region through the possible establishment of an Intergovernmental Negotiating Group (ING).¹</p> | <p>Improved policies for sustainable housing and real estate markets</p> |

The cluster addresses land registration, e-governance, land tenure, spatial information and cadastres. The Committee is currently developing guidelines for the preparation of the country profiles.
