**INFORMATION NOTE FOR PARTICIPANTS**

Date and venue of the plenary session

1. The 50th Plenary Session will be held at the OECD headquarters at 2, rue André Pascal, Paris 75016, from Monday 10 June until Wednesday 12 June 2002. The meeting will commence at 2:30 p.m. on Monday 10 June and will finish on Wednesday at 5:00 p.m. It will be held in Salle 1 in the main building.

Accommodation, passports and visas and travel arrangements

2. All participants attending the meeting are requested to have a valid passport and, if required, a visa for France. Applications for visas should be made to the embassy or consulate of France in the country in which the participants reside. Visa applications should refer to the 50th plenary session of the Conference of European Statisticians to be held at the OECD premises in Paris. If a formal invitation letter is required by the embassy, this can be requested from the UNECE secretariat (fax: ++4122 917 00 40) or directly from the OECD secretariat, attention Mrs. Anne Hamilton (fax: ++331 4430 6322)
