What is the Conference ?

- The Conference is one of the oldest statistical bodies working on international statistics. It is the governing body on statistics of UNECE
- Stemming from the first Conference of Statistics held under the League of Nations in 1928, the CES was founded in 1953
- The CES Bureau, composed of Chief Statisticians from 8 countries and 6 international organizations, steers the work

What does the Conference do ?

- Coordinates international statistical work in the region
- Develops guidelines and recommendations on statistical methodology through dedicated Task Forces
- Builds capacity to improve national statistics
- Collects and disseminates internationally comparable statistics

Who is in the Conference ?

- Chief statisticians of the member countries of UNECE, OECD and beyond, and international organizations
- All United Nations member countries can become members

Major CES achievements

Fundamental Principles of Official Statistics

- 1991: the Principles were adopted by the Conference of European Statisticians
- 1992: UNECE adopted the Principles at the political level
- 1994: the Principles were adopted by the United Nations Statistical Commission
- 2013: Economic and Social Council endorsed the Principles
- 2014: United Nations General Assembly endorsed the Principles at the highest political level

Types of outputs

- Recommendations and Guidelines – prepared in collaboration with national and international experts
- Standards for statistical production – produced under the CES High-Level Group for the Modernisation of Statistical Production and Services
- Knowledge bases – over 60 UNECE wikis for international statistical development work
- In-depth reviews – studies on selected strategic issues to identify gaps and new issues
- Global Assessments of national statistical systems in EECCA countries – provide, at countries' request, recommendations for improving national capacity to produce official statistics
- Library of Training Materials – shares generic training materials in statistics
- Statistical Database – on-line statistics on UNECE member countries, in English and Russian
- Database of the International Statistical Activities of over 30 international organizations active in the UNECE region

Seminars and expert meetings

CES seminars and expert meetings offer a platform to exchange experiences and discuss new conceptual work and emerging topics. They promote the implementation of standards to accelerate the development of official statistics.
