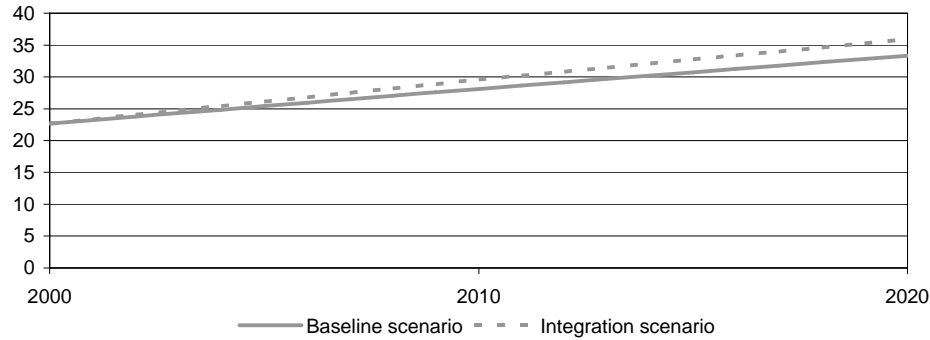

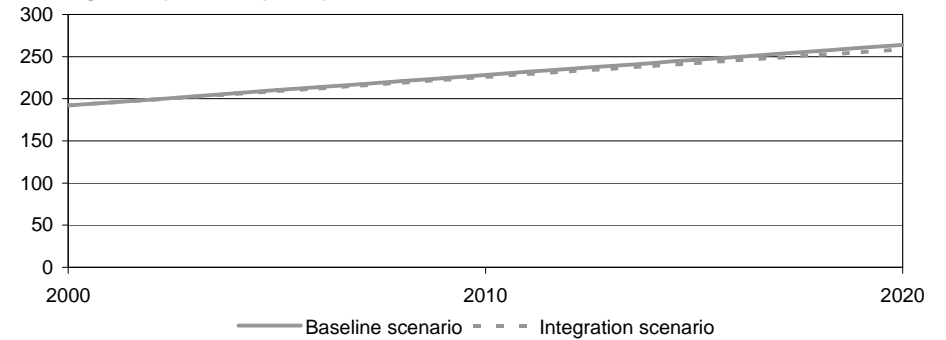

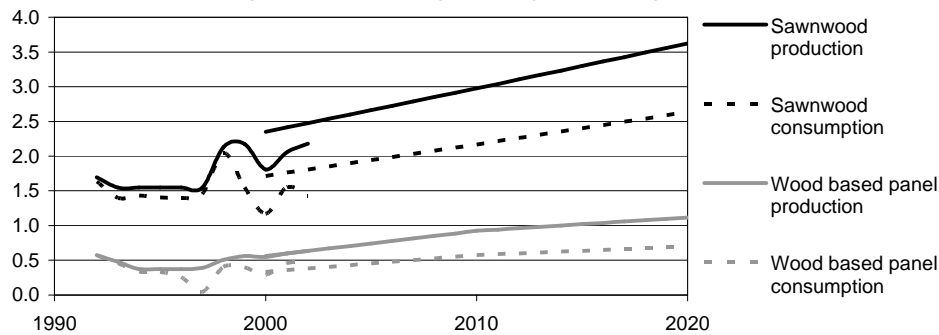
Ratio of fellings to increment (in percent)



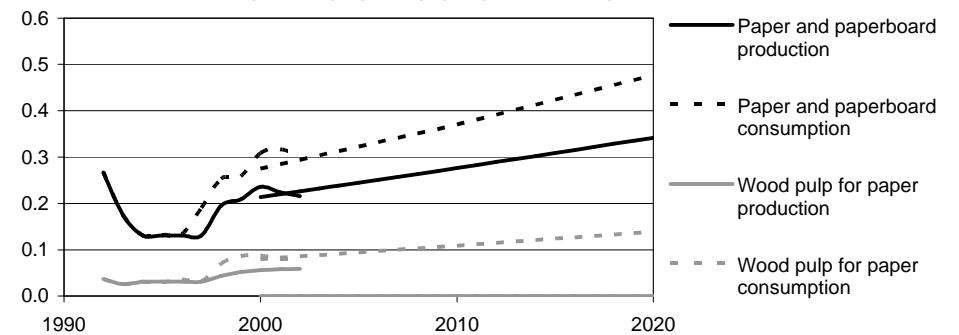
Growing stock (in m³ o.b. per ha)



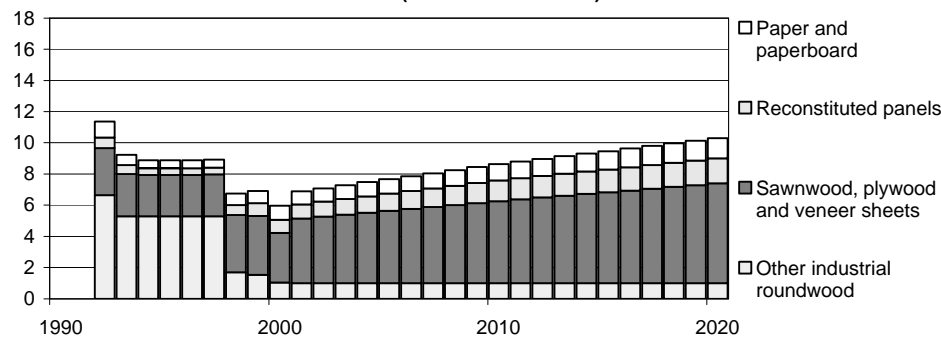
Production and consumption of solid wood products (in million m³)



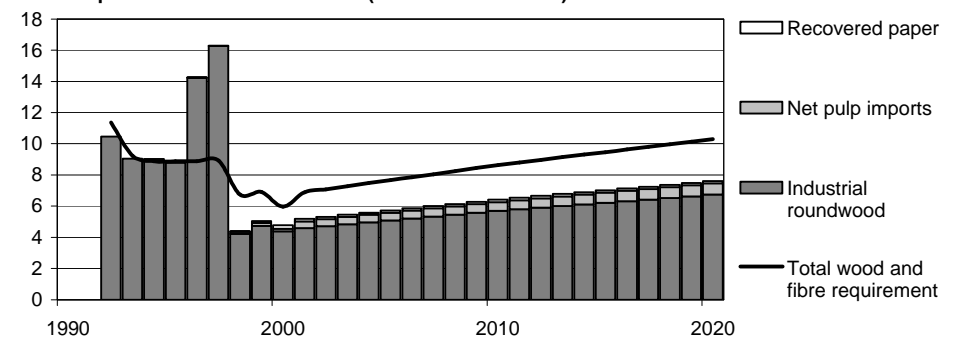
Production and consumption of pulp and paper (in million MT)

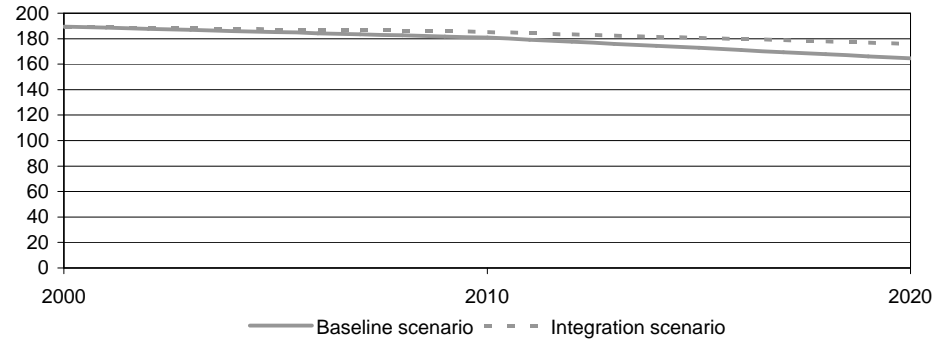

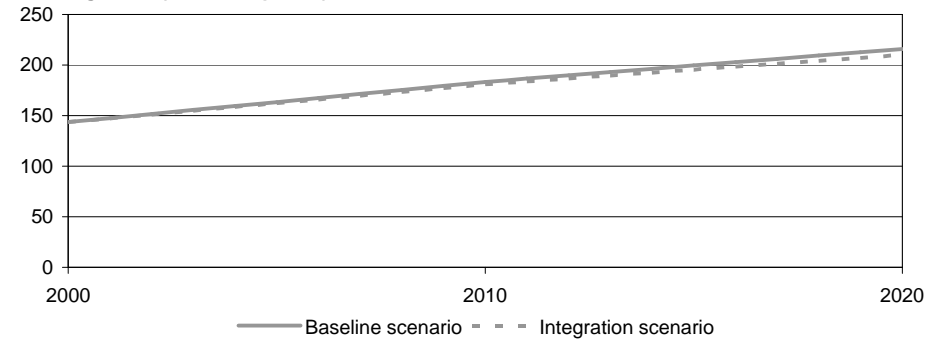

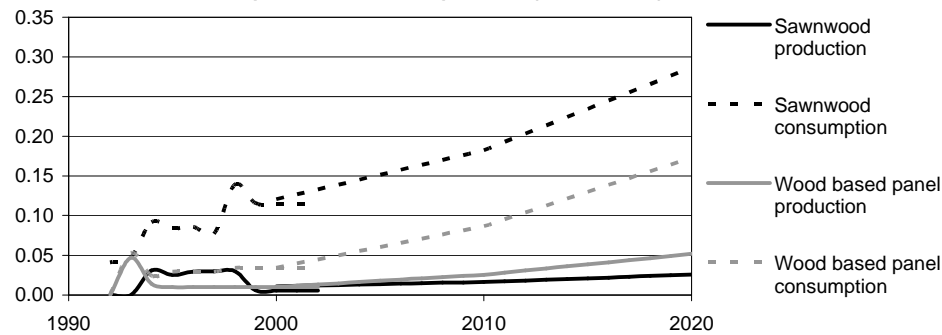
Ratio of fellings to increment (in percent)



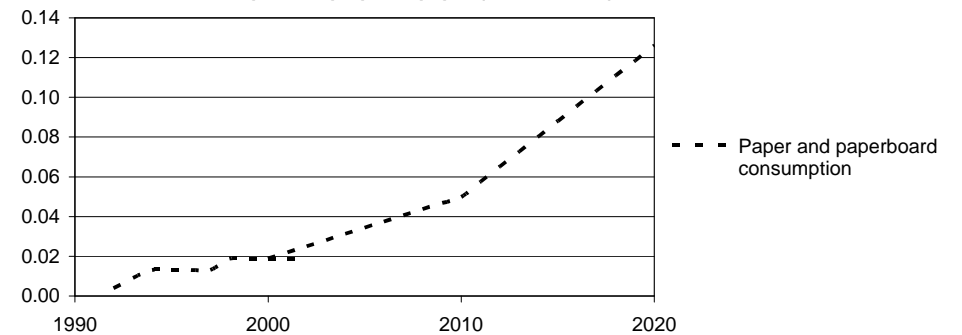
Growing stock (in m³ o.b. per ha)



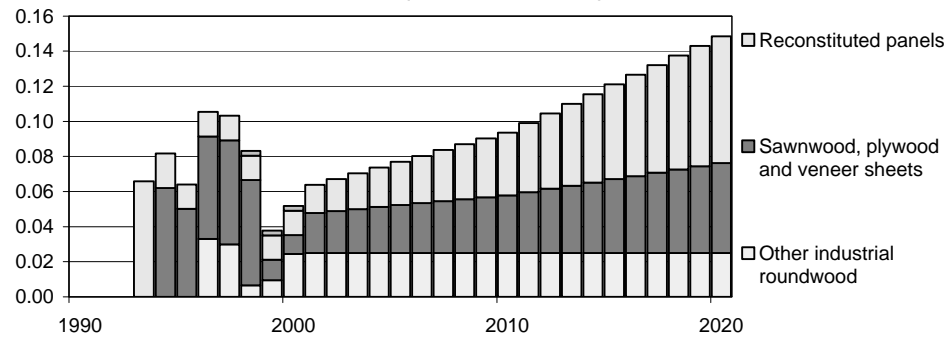
Production and consumption of solid wood products (in million m³)



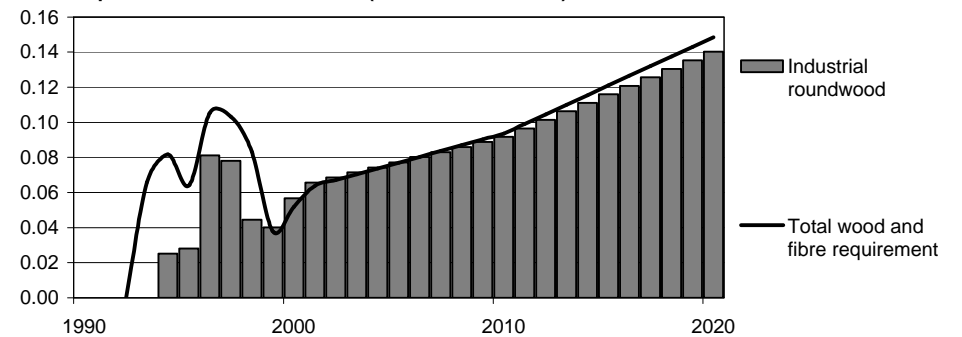
Production and consumption of pulp and paper (in million MT)

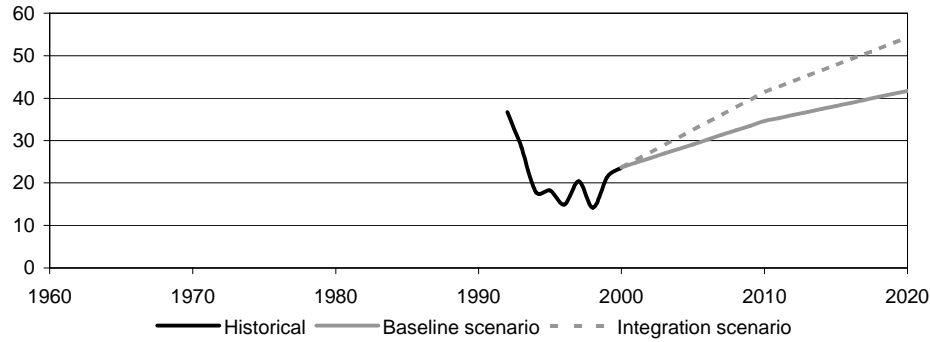

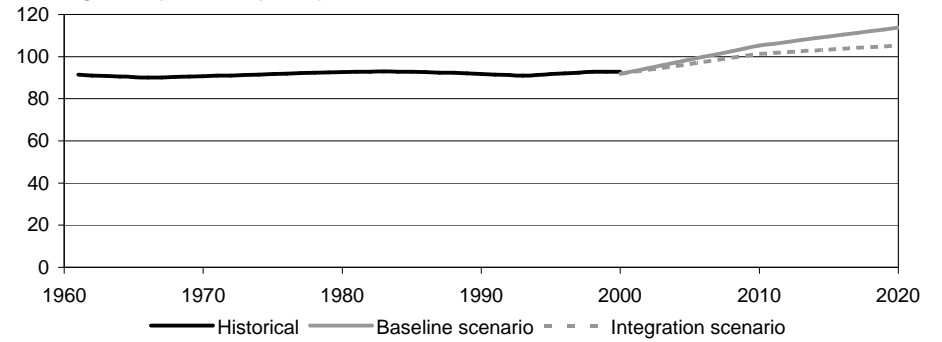

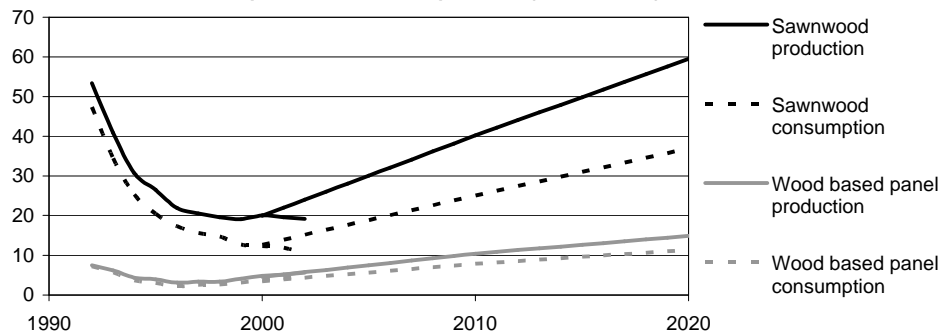
Ratio of fellings to increment (in percent)



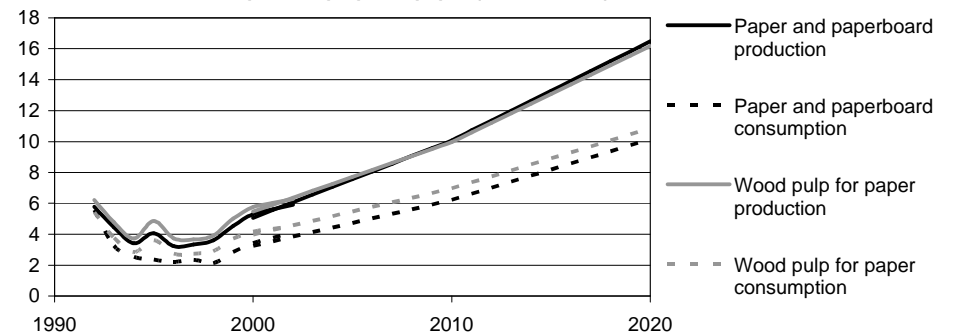
Growing stock (in m³ o.b. per ha)



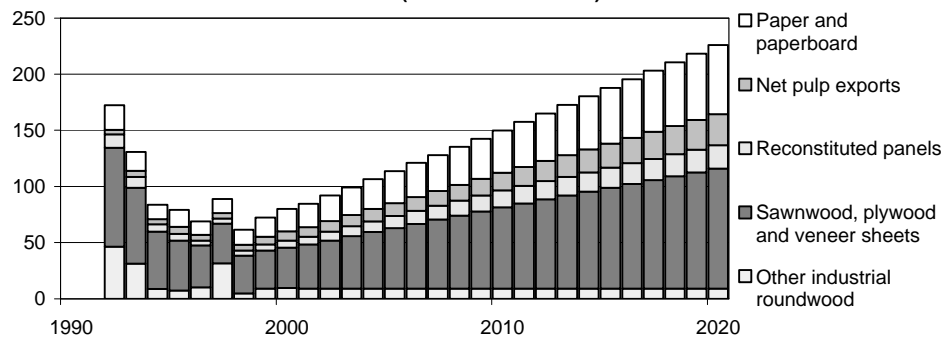
Production and consumption of solid wood products (in million m³)



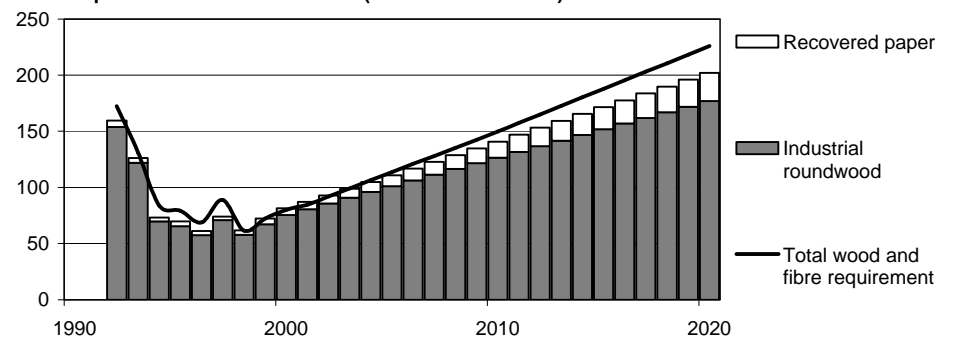
Production and consumption of pulp and paper (in million MT)

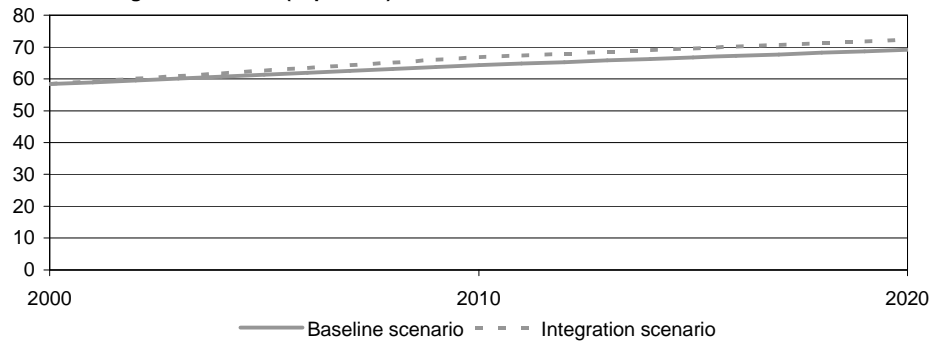

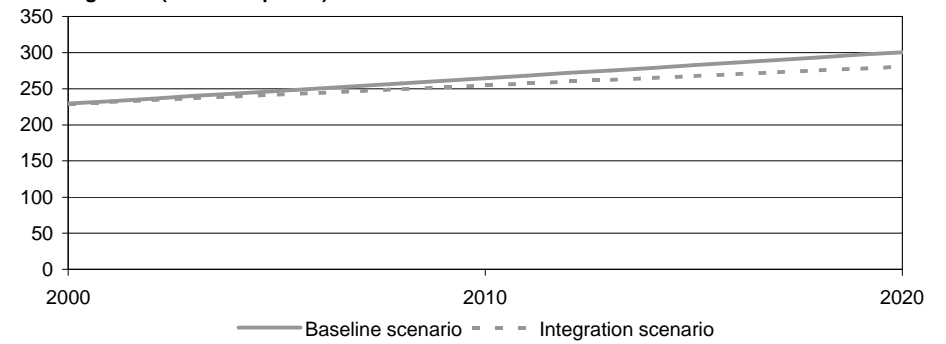

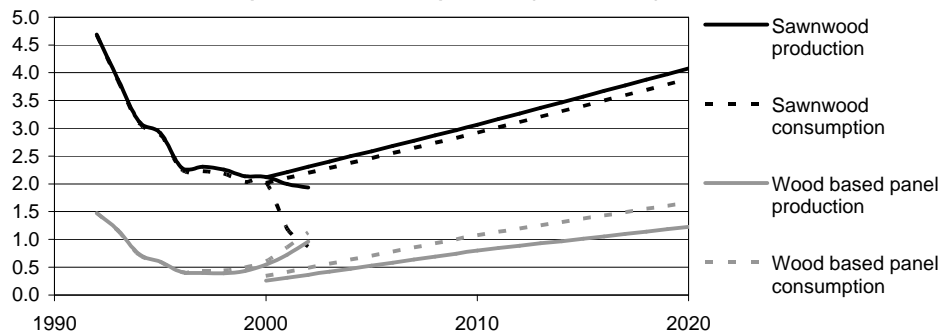
Ratio of fellings to increment (in percent)



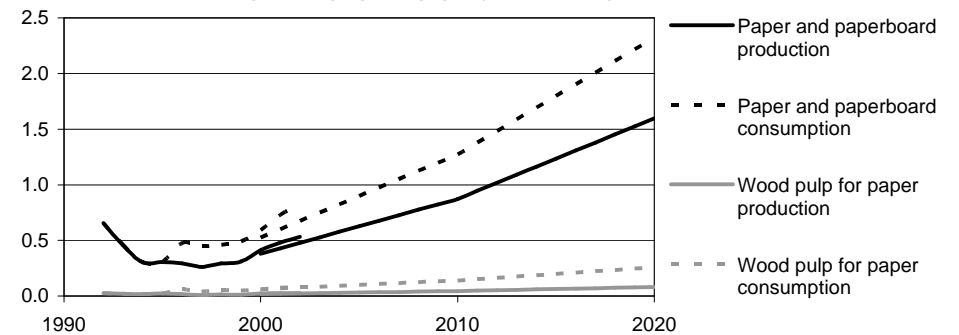
Growing stock (in m³ o.b. per ha)



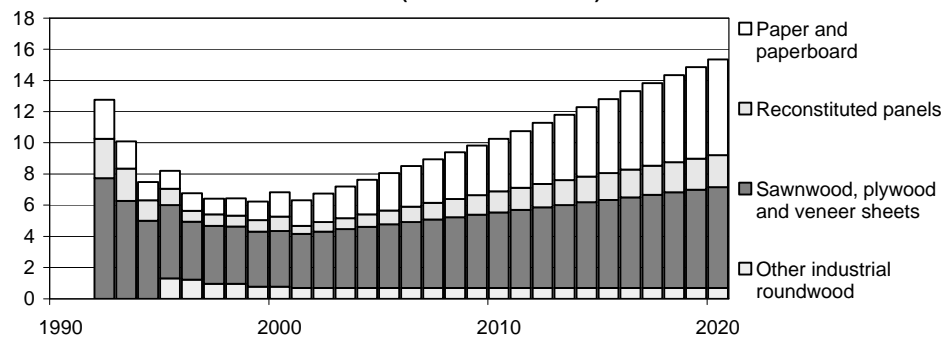
Production and consumption of solid wood products (in million m³)



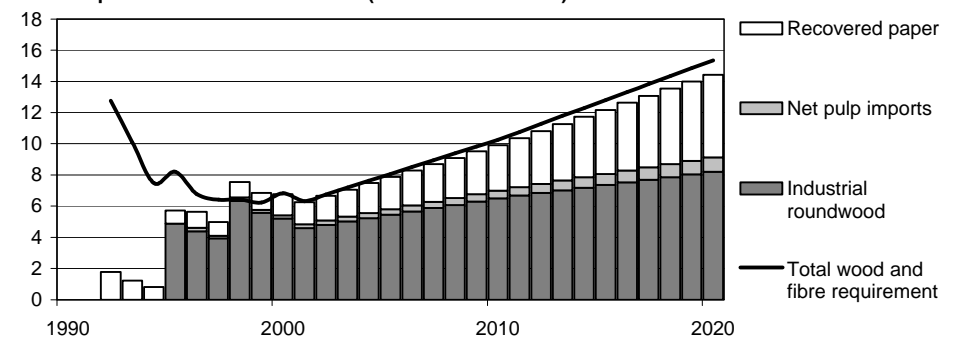
Production and consumption of pulp and paper (in million MT)
