**Report of the fortieth session of the Joint  
ECE/FAO Working Party on Forest Statistics,  
Economics and Management****Introduction**

1. The Joint ECE/FAO Working Party on Forest Statistics, Economics and Management (henceforth referred to as Joint Working Party) held its fortieth session in Geneva on 22 March 2018.
2. The original dates of the session were 22-23 March 2018. However, due to the announcement of a strike of the United Nations staff taking place on 23 March 2018, the Joint Working Party agreed to complete the work in one day by working additional hours. More detailed information on this matter can be found in paragraphs 8-10 of the report.

**Attendance**

3. Delegations from the following member States participated in the meeting: Austria, Czech Republic, Estonia, Finland, Germany, Ireland, Latvia, the Netherlands, Norway, Poland, Portugal, Serbia, Sweden, Switzerland, Turkey, Ukraine, the United States of America and Uzbekistan.
4. A representative of the European Commission participated in the session.
5. The following United Nations (UN) bodies and agencies participated in the session: the United Nations Economic Commission for Europe and the Food and Agriculture Organization of the United Nations (FAO).
6. Representatives of the following non-governmental organizations participated in the session: Crann-Trees for Ireland, European Organization of the Sawmill Industry, PanBern, the Polish Wood Technology Institute, the Programme for the Endorsement of Forest Certification Schemes (PEFC), the Sustainable Forestry Initiative (SFI) and the Thünen Institute.

## **Item 1: Adoption of the agenda**

7. The meeting was opened by Mr. Jeffrey Prestemon of the United States of America, Chair of the Joint Working Party.
8. The Chair invited the secretariat to inform the Joint Working Party about the announcement of a strike of UN staff envisaged for the following day, 23 March 2018.
9. The Joint Working Party agreed to reduce the session to one extended day by compressing the work load and foregoing interpretation after 6 p.m. The Joint Working Party also agreed that the report of the meeting would be drafted by the Working Party Bureau with the support of the secretariat and that the report shall be adopted with tacit consent, pending any amendment from the Working Party after emailing the draft report to the Joint Working Party.
10. Detailed information on the content of all presentations is available in the background documents of the meeting, and highlights are available in the annotated agenda for the meeting (ECE/TIM/EFC/WP.2/2018/1). All documents can be found on the ECE website.
11. The agenda was adopted without amendments, in line with the working arrangements above.

## **Item 2: Outcomes of the joint seventy-fifth session of the ECE Committee on Forests and the Forest Industry and the thirty-ninth session of the FAO European Forestry Commission**

12. The secretariat presented the Warsaw Integrated Programme of Work 2018-2021 (WIPOW), adopted at the joint seventy-fifth session of the ECE Committee on Forests and the Forest Industry (COFFI) and the thirty-ninth session of the FAO European Forestry Commission (EFC), held in Warsaw, Poland, from 9 to 13 October 2017.
13. The Joint Working Party took note of the information provided by the secretariat.

## **Item 3: Update on international policy processes with an impact on forests**

14. The secretariat updated the Joint Working Party on the upcoming twenty-fourth session of the FAO Committee on Forestry (COFO24), which will be held in Rome, Italy, from 16 to 20 July 2018, and informed participants that the meeting agenda will be shared with member States shortly.
15. Ms. Liubov Poliakova, Ukraine, informed the Joint Working party on decisions by the twelfth session of the United Nations Forum on Forests (UNFF12), held in New York, United States of America, on 1-5 May 2017. This included intersessional activities as well as the provisional list of items to be addressed at the thirteenth session of the United Nations Forum on Forests (UNFF13), to be held in New York, United States of America, from 7 to 11 May 2018.
16. The Joint Working Party took note of the information provided.

## **Item 4: Guidance on work areas**

17. The Joint Working Party was informed on the work and results achieved since the previous Joint Working Party meeting in March 2017 for all Team of Specialists.

## **Work area 1: Data, monitoring, reporting and assessment**

### **Forest resources**

18. The secretariat provided a brief update on the work undertaken on reporting on forests and sustainable forest management.

19. The secretariat expressed its gratitude to national and international experts, including national correspondents and members of the Team of Specialists, as well as the governments of Georgia, Norway, the Russian Federation and Switzerland, for their input and support to the work of the secretariat. The secretariat also recognized the excellent cooperation with international organizations involved in this work.

20. Mr. Stein M. Tomter, leader of the Team of Specialists on Monitoring Sustainable Forest Management, presented activities of the Team of Specialists in 2017 and 2018 and on the work planned until the next session of the Joint Working Party.

21. The Joint Working Party:

(a) welcomed the information provided and expressed satisfaction with the progress of work on the 2020 global and regional reporting;

(b) supported the proposed plan for future work pertinent to the forest resources assessment in the framework of global and regional reporting;

(c) took note of the decision by the Committee on Forests and the Forest Industry and the European Forestry Commission to not continue work on the System for Evaluation of the Management of Forests (SEMAFOR);

(d) appreciated the update on the activities implemented by the Team of Specialists on Monitoring Sustainable Forest Management and agreed with the direction of work and actions proposed, including the establishment of an informal forest databank network and the analysis of the reporting on forest damages;

(e) requested that the secretariat provide more information to member States about the initiatives proposed by the Team of Specialists in due course.

### **Forest products statistics**

22. Mr. Branko Glavonjic, leader of the Team of Specialists on Forest Products Statistics, presented the report of the Team of Specialists.

23. The secretariat provided information about the status and the next steps for amending product classification under the Harmonized System 2022 (HS 2022).

24. The Joint Working Party:

(a) took note of the work on conversion factors and requested that the secretariat inform the European Environment Agency, Eurostat and Forest Europe on the status of this study;

(b) encouraged changes to HS 2022, particularly on engineered wood products, and invited the secretariat to solicit support from delegates for this process, if necessary;

(c) welcomed the progress made to assess data on the circular economy, noting the addition of recovered wood in the Joint Forest Sector Questionnaire, and encouraged further work in this area;

(d) expressed support for the work of the Team of Specialists on Forest Products Statistics and called on member States to nominate additional members;

### Forest product markets

25. The Joint Working Party was briefed by the secretariat on plans for the *Forest Products Annual Market Review 2017-2018*, and was invited to provide guidance on its quality, content and timing. The plan for this year's special chapter is to cover high-performance wood construction and related barriers and incentives. The secretariat invited the Joint Working Party to suggest experts who could provide country-specific information for use in the special chapter.

26. The secretariat thanked the Russian Federation for providing funding for the 2017 edition of the *Forest Products Annual Market Review*, as well as the Team of Specialists on Sustainable Forest Products for proof-reading and providing expertise, the University of Helsinki for providing interns, and the Joint Forest Sector Questionnaire correspondents, authors and partners.

27. Mr. Eoin O'Driscoll, leader of the Team of Specialists on Sustainable Forest Products, presented the achievements and activities of the Team in 2017 and their tentative plans for 2018.

28. The Joint Working Party:

(a) acknowledged the financial support provided by Finland for the 2018 *Forest Products Annual Market Review*;

(b) recognized the importance of the work on forest products markets and the contributions of the Team of Specialists. Country Market Statements were identified as a potential source of information on wood construction and other topics as well as for inclusion in the *Market Review*;

(c) supported the drafting of a special chapter on wood construction and suggested that innovative use of wood, such as for production of chemical extracts, could be a topic to consider for future special chapters;

(d) stressed the importance of involving the private sector in discussions and work on forest products markets. Making information in the *Market Review* more relevant to the private sector, could be one way of increasing the involvement of industry representatives;

(e) pointed out, in particular regarding the Team of Specialists on Sustainable Forest Products but also more generally regarding all teams, that it would be helpful to keep the lists of Teams of Specialists up to date and available on the website, and periodically distribute them to member States' focal points. In this regard, it requested the secretariat to update the website in a timelier manner.

29. Mr. Jeremy Wall from the European Commission elaborated on the development of good-practice guidance on the cascading use of wood, as required under the EU's Circular Economy Action Plan (CEAP). The guidance would be in the form of an "information document" (not legally binding), most likely a "staff working document" (SWD), being produced by the Commission during 2018. Delegates were invited to contribute good-practice case studies to the Commission, including through a stakeholder workshop on 13 April 2018. The Joint Working Party noted that the "information document" could be used as a basis for a good practices handbook on the cascaded use of wood. The secretariat will pursue the opportunity for cooperation between the EU and other UNECE Member States on the cascading use of wood and will start by providing more information on the work of the European Commission on the ECE website ([www.unece.org/fileadmin/DAM/timber/meetings/2018/20180322/EC-invitation-circular-economy.pdf](http://www.unece.org/fileadmin/DAM/timber/meetings/2018/20180322/EC-invitation-circular-economy.pdf)).

30. The secretariat informed delegates about the preliminary programme and status of the organization of the seventy-sixth session of the ECE Committee on Forests and the Forest Industry, to be held in Vancouver, Canada, from 5-9 November 2018.

31. The Joint Working Party:

(a) supported the idea of a “Declaration” addressing the importance of wood products for sustainable development to be signed by stakeholders after it has been approved by the Committee;

(b) expressed its support for the proposed programme of the session and agreed to participate in the preparation of the draft Declaration.

### **Wood Energy**

32. The secretariat provided a short update on the work of the Team of Specialists on Wood Energy. The secretariat also thanked the United States of America for hosting the last meeting of the Team and acknowledged Finland’s financial and in-kind support for the publication, *Wood Energy in the ECE Region*.

33. Mr. Sebastian Glasenapp, Thünen Institut, presented the latest results of the Joint Wood Energy Enquiry for the reference year 2015. The presentation can be found on the ECE website. Some of the information from the Joint Wood Energy Enquiry 2015 has already been used for the upcoming publication, *Wood energy in the ECE Region*.

34. The Joint Working Party:

(a) provided guidance on the future data collection for the Joint Wood Energy Enquiry and publication of results;

(b) encouraged the secretariat to further improve the harmonization of wood energy data throughout relevant databases in the forest and other sectors (Joint Forest Sector Questionnaire/FAO statistics, Forest Resources Assessment, State of Europe’s Forests, Group of Experts on Renewable Energy, Environmental Performance Reviews, etc.);

(c) requested publication of the wood energy data earlier than in previous years, ideally within one year after the launch of the Joint Wood Energy Enquire;

(d) agreed that the next round of the Joint Wood Energy Enquiry (for the reference year 2017) should be launched in autumn 2018 and be presented to the forty-first session of the Joint Working Party in 2019;

(e) proposed organizing capacity-building workshops every two years, in line with the reporting cycle of the Joint Wood Energy Enquire;

(f) agreed that the Joint Wood Energy Enquiry results should be available through:  
(i) short country profiles addressed to policy makers, containing aggregated information on sources, users of wood energy, trends over time and comparison to other renewable energy and energy consumption; (ii) a searchable, interactive database hosted by the ECE Statistics Division, which provides data on sources and users of wood energy by country; (iii) a compressed flat-file of the entire dataset for download.

35. The secretariat informed the Joint Working Party that the reduction in the number of members in the Team of Specialists on Wood Energy is a result of the review of their membership under the new programme of work. The Team invited members of the Joint Working Party to encourage participation and nominate additional participants to ensure adequate expertise.

### **Work Area 2: Policy dialogue and advice**

36. Mr. Michal Synek, Czech Republic, briefed the Joint Working Party on the outcome of the international conference “Marianske Lazne +70”, which took place in Czech Republic on 5-7 September 2017 to celebrate seventy years of ECE and FAO cooperation on forests. The event also included a roundtable on forest certification in the ECE Region.

37. Mr. Christoph Dürr, Switzerland, reported on the outcomes of the roundtable discussion on “Sustainable Forest Management and the Sustainable Development Goals”, held during the “Regional Forum on Sustainable Development for the ECE Region” in Geneva, Switzerland, on 1 March 2018.

38. The secretariat informed the Joint Working Party that in 2019, the “Regional Forum on Sustainable Development for the ECE Region” will be held on the same date as the International Day of Forests. The theme of the International Day of Forests 2019 will be “Forests and Education”. The Regional Forum on Sustainable Development for the ECE Region in 2019 will review, among others, SDG 4 “Ensure inclusive and quality education for all and promote lifelong learning”.

39. The secretariat, on behalf of Mr. Kanat Rakhmetov, Republic of Kazakhstan, informed the Joint Working Party about the upcoming Ministerial Roundtable on Forest Landscape Restoration and the Bonn Challenge in the Caucasus and Central Asia, which will be held in Astana, Kazakhstan, on 21-22 June 2018.

40. The secretariat also provided an update on the mid-term review of the Rovaniemi Action Plan for the Forest Sector in a Green Economy, undertaken under the guidance of the Team of Specialists on Forest Policy (Forest Policy Network) and presented an overview of the Joint Section’s activities contributing to the implementation of the Rovaniemi Action Plan.

41. Ms. Marta Gaworska, leader of the Team of Specialists on Forest Policy (Forest Policy Network), provided an overview of the past and planned activities of the Team of Specialists.

42. The Joint Working Party:

(a) welcomed the opportunity to promote forest education during the next International Day of Forests and requested that the secretariat explore the possibility of organizing a roundtable focused on “Forests and Education” at the Regional Forum on Sustainable Development in 2019;

(b) recognized the work of the Forest Policy Network and the work on the Rovaniemi Action Plan;

(c) stressed the need of further discussion on the future of the Rovaniemi Action Plan and the need to link it with the SDGs and suggested the use of electronic communication with an aim to promote the adoption of the Rovaniemi Action Plan to a wider audience;

(d) acknowledged the wide array of policy issues and suggested that the ToS should focus their work to a smaller area of priority issues;

(e) emphasized that the team work more closely with other ToSs, namely the ToS on Forest Sector Outlook;

(f) noted the need to examine how other policies impact work in the forest sector and the benefits of communicating forest policy to other sectors. In that context, policy updates and briefs prepared by the secretariat have been helpful and should be continued.

### **Forest Sector Outlook**

43. Mr. Mart-Jan Schelhaas, researcher at the Centre for Ecosystems Studies Wageningen Environmental Research and former leader of the Team of Specialists on Forest Sector Outlook, presented the activities and achievements of the Team during the previous year; including possible scenarios (and their technical feasibility) to be included in the next Forest Sector Outlook Study. Mr. Schelhaas informed the meeting that Ms. Tuula Packalen, Professor at the Natural Resources Institute Finland, had been elected as new Outlook Team leader.

44. The secretariat briefed the Joint Working Party about the roadmap for the development of the next Forest Sector Outlook Study.

45. The secretariat invited the Joint Working Party to send information about current or planned activities in member States regarding outlook studies after the session by email.

46. Several delegates discussed priorities with respect to the presented list of scenarios. Given the short time available, the secretariat noted that it would send the list of scenarios to delegates after the session in order to receive further guidance. Some delegates suggested adding a scenario on nature conservation. It was noted that the final decision on scenarios should be based on relevance, feasibility and resource implications.

47. The Joint Working Party:

(a) agreed that 2040 would be a reasonable projection year for the currently planned Forest Sector Outlook Study;

(b) indicated a preference for having a study covering the whole ECE region, ideally with an integrated modelling for all sub-regions. Some participants mentioned that outlook information at the national level would provide valuable additional information;

(c) stressed the importance of capacity-building in the area of outlook studies. This could also help to decrease costs and time for future studies, enabling countries to contribute in the future;

(d) stressed that member States can increase their capacities by participating actively in the development of the current Forest Sector Outlook Study.

48. The secretariat and Mr. Schelhaas invited countries currently not represented in the Team of Specialists on Forest Sector Outlook to consider appointing a national representative to the Team. The secretariat also invited the Joint Working Party to contribute to the development of the current outlook study by sharing their relevant national data in order to increase the accuracy of the results. In this regard, the Working Party:

(a) invited member States to appoint national focal points for this process. It was added that this could also be done in the form of membership in the Team of Specialists on Forest Sector Outlook;

(b) suggested that the results of the modelling work could feed into policy briefs. These should contain policy opportunities rather than policy recommendations;

(c) stressed the importance of consultations and dialogue throughout the process of the development of the outlook study, as well as consultation with other relevant Teams of Specialists ensuring that emerging trends and data are given consideration in the context of the study;

(d) suggested exploring possible synergies and cooperation with related work by the European National Forest Inventory Network, the International Institute for Applied System Analysis, and Forest Europe;

(e) noted that current resources available are not sufficient to deliver a good quality study covering various scenarios. The Joint Working Party invited interested member States and other stakeholders to support the outlook study through in-kind and financial contributions.

### **Work Area 3: Communication and outreach**

49. Ms. Magdalena Wolicka, member of the Team of Specialists on Forest Communication (Forest Communicators' Network), presented the achievements and activities of the Team in 2017. This included the fourth European Forest Week, which was hosted by Poland and plans for 2018.

50. The secretariat informed the Joint Working Party on the upcoming communication strategy for the secretariat, including major events, publications and outreach activities. The secretariat also noted that the International Day of Forests 2019, with the theme "Forests and Education", will coincide with the ECE Regional Forum on Sustainable Development (see Work Area 2).

51. The Joint Working Party:

(a) reiterated its recommendation to use the upcoming opportunity for synergies between the International Day of Forests 2019 and the ECE Regional Forum on Sustainable Development, requesting that the secretariat organize the International Day of Forests in conjunction with the Forum;

(b) recommended extending communication activities to target groups outside the forest sector.

#### **Work area 4: Capacity-building**

52. The secretariat informed the Joint Working Party about the planned capacity-building activities in the area of green jobs in the forest sector.

53. Mr. Andreas Bernasconi, leader of the Team of Specialists on Green Jobs in the Forest Sector (Joint ILO/ECE/FAO Expert Network), presented the past and upcoming activities of the Team of Specialists.

54. The Joint Working Party:

(a) took note of the information provided and appreciated the work done and the planned activities of the ToS on Green Jobs;

(b) suggested supporting research on the national criteria and indicator sets for sustainable forest management (drafted by the five project countries) as it relates to the project on Accountability Systems for Sustainable Forest Management in the Caucasus and Central Asia;

(c) expressed appreciation for the wood balance work, urging further development in this area on a regular (but not annual) basis. Data should be calculated over a larger interval to avoid problems with stock changes.

#### **Item 5: Overview on the Economic Commission for Europe and the Food and Agriculture Organization of the United Nation's forest-related work in the region and list of Warsaw Integrated Programme of Work activities 2019**

55. The secretariat presented a tentative list of activities planned for 2019 to the Joint Working Party. In line with the Warsaw Integrated Programme of Work 2018-2021 (ECE/TIM/2017/2-FO:EFC/2017/2), the Joint Working Party reviewed the list of activities as contained in the document "List of activities to implement the Warsaw Integrated Programme of Work: Activities and publications planned for 2019".

56. The list of activities, reflecting amendments by the Joint Working Party, was approved as contained in the Annex.

57. The meeting was also informed about ECE and FAO activities beyond the Warsaw Integrated Programme of Work.

58. Ms. Anukka Lipponen provided an overview of forest-related work under the water and energy nexus work by the ECE Environment Division.

59. Mr. Gianluca Sambucini of the ECE Sustainable Energy Division presented the work of the Group on Renewable Energy Experts.

60. The presentation from the ECE Forests, Land and Housing Division, as well as other presentations from the Environment Division are available on the ECE website.

61. Ms. Alicja Kacprzak of the Joint Section provided an overview of FAO's work, outside of the Warsaw Integrated Programme of Work, on forests in the ECE Region. The Joint



Working Party was informed that a more detailed version of the presentation was sent to delegates by email and is available on the ECE website.

### **Item 6: Any other business**

62. As in previous years, the secretariat inquired with the Joint Working Party whether it requires official documentation (parliamentary documents) as the background documents for the meeting or whether the meeting agrees to continue with informal documents in English only. The annotated agenda and the report from the meeting would continue to be the only official documents prepared.

63. The Joint Working Party confirmed their preference for issuing only the annotated agenda and the meeting report as official documents, while the other meeting documents could be issued as informal documents. However, in the absence of France and the Russian Federation in the meeting, the Joint Working Party requested that the secretariat obtain feedback from these two countries in due time before the next session.

### **Item 7: Date and place of next meeting**

64. The Joint Working Party took note of the current plans by the ECE to hold the Regional Forum on Sustainable Development during the week of 18-22 March 2019 and agreed that the forty-first session of the Joint ECE/FAO Working Party on Forest Statistics, Economics and Management will be held on 27-29 March 2019.

65. The Joint Working Party requested a three-day session to allow sufficient time for discussion for preparing for the joint session of the COFFI and the EFC in 2019 and allow for interactive sessions.

### **Item 8: Election of officers**

66. At the end of the fortieth session, Mr. Jeff Prestemon, United States, Chair of the thirty-ninth and fortieth sessions, was elected as Vice-Chair. Mr. Matthias Dieter, Germany, Vice-Chair of the thirty-ninth and fortieth sessions, was elected as the new Chair. Ms. Magdalena Wolicka, Poland, was elected as new Vice-Chair. They will hold office until the end of the forty-first session.

67. The Working Party expressed its appreciation to Mr. Johannes Hangler for his dedication and service as chair and vice chair of the Working Party from 2013-2018.

### **Item 9: Adoption of the report**

68. The Joint Working Party adopted its report via electronic means through tacit consent.

69. The Chair closed the meeting at 8 p.m.
