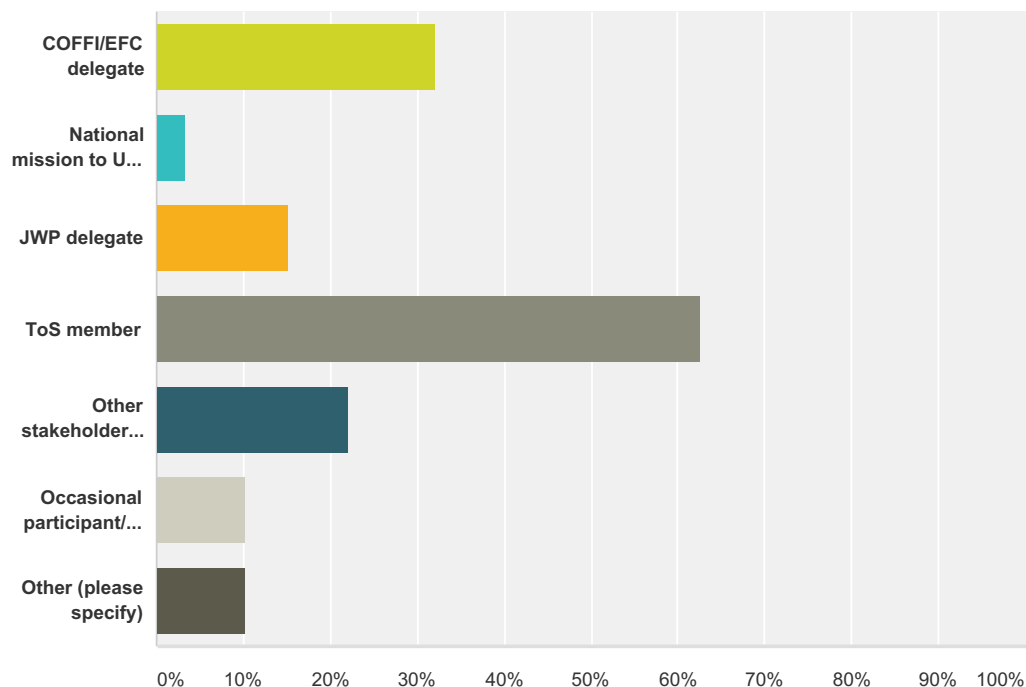


Q1 In what ways have you been involved in the implementation of the integrated programme of work 2014-2017?

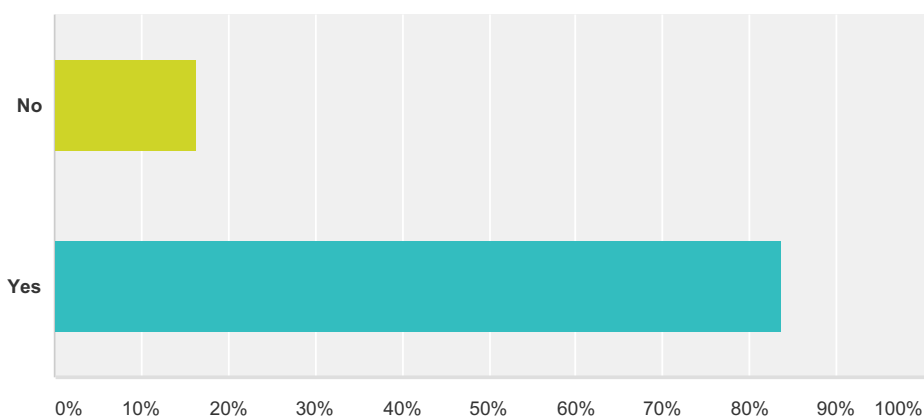

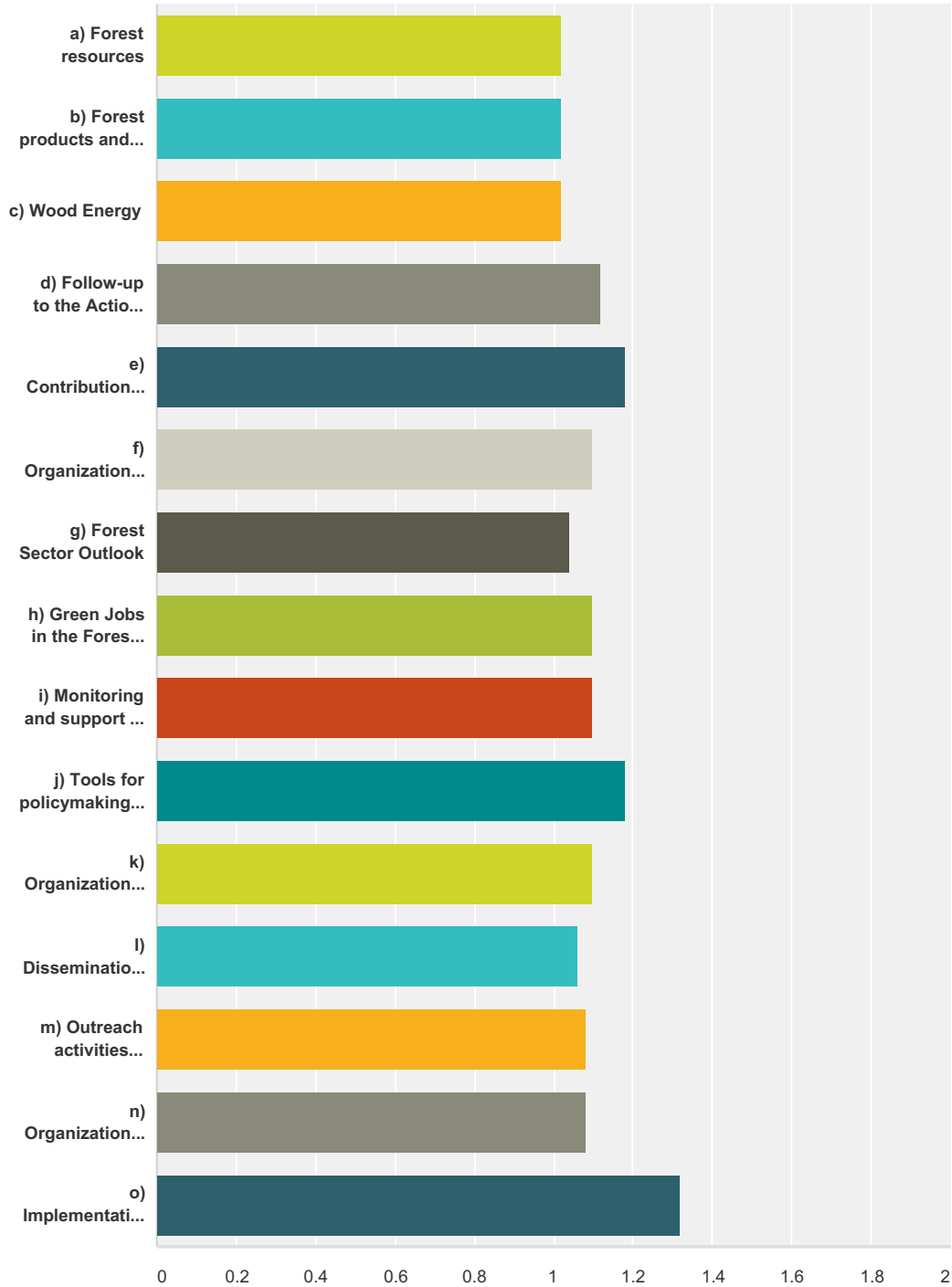

When it comes to implementing the priorities set by ministers both the Forest Europe program of work and the IPoW of the UNECE/FAO play a vital role. Although the Forest Europe PoW has identified some clear synergies with the ongoing work by UNECE/FAO (such as the theme of green jobs & green economy as well as the promotion of SFM tools and the data-related work on criteria and indicators for SFM) we do see major opportunities for an even more intensive search for synergies (e.g. forest ecosystem services in a green economy; social values in SFM amongst others) and consequent cooperation. A strengthened partnership in this regard would be beneficial in terms of increased output and increase cost-efficiency for e.g. countries.
