ENTRY INTO FORCE OF AMENDMENTS TO ANNEX 2

The Secretary-General of the United Nations, acting in his capacity as depositary, and referring to depositary notification C.N.41.1988.TREATIES-1 of 13 May 1988 transmitting inter alia the text in English, French and Russian of the amendments proposed to annex 2 of the Convention, communicates the following:

None of the Contracting Parties to the above-mentioned Convention having expressed an objection by 1 May 1988, the amendments in question, in accordance with the decision of the Administrative Committee, taken at its tenth session held in Geneva from 18 to 20 November 1987, will enter into force on 1 August 1988.
