1. Adoption of the agenda

2. Matters of interest since the last session

(a) UNECE and subsidiary bodies

The secretariat will inform the delegates about the outcome of the November 2014 session of the Working Party and of other decisions by the UNECE governing bodies which might have an impact on the work of the Specialized Section.

3. Standards on trial

The Specialized Section will review the Standard for Sweet Chestnuts and the draft Standard for Lambs Lettuce. At its 2014 session, the Working Party put them on trial as recommendations through November 2015.

The Specialized Section may wish to follow up on its decision to develop an electronic version of an explanatory brochure for lambs lettuce.

4. Explanatory brochure and Standard for Persimmons

The delegations will consider the Recommendation for Persimmons as well as the text and photographs of the draft brochure. To allow countries to consult with the industry, the documents containing the proposals for amendments developed by the Working Group at its meetings in Valencia (November 2013), Faenza (October 2014) and Geneva (November 2014) were circulated to delegations in November 2014. The Specialized Section may wish to take a decision on recommending the brochure and the standard to the Working Party for approval.

5. Revision of UNECE standards

(a) Citrus fruit

The delegation of South Africa will present the proposals of the Working Group on citrus fruit labelling. The Working Group agreed on these proposals at its meeting in Geneva in November 2014. Following the meeting, the secretariat circulated the report containing the proposals. The Specialized Section will revisit the "Definition of produce" and "Provisions concerning marking" sections of the standard to decide on how the labelling-related provisions could be made less ambiguous and easier to follow.

(c) Truffles

The delegation of France will provide information on the recent changes in the French national regulation concerning this product. The Specialized Section will review the "Definition of produce" section of the Standard for Truffles accordingly.

(d) Garlic

The delegation of Spain will make proposals on revising the Standard for Garlic to reflect the results of the OECD work on an explanatory brochure for this product.

(e) Watermelons

The Specialized Section will continue its work on revising the Standard for Watermelons using the 2014 post-session text of the standard.

(f) Early and ware potatoes

The delegation of Hungary is expected to provide information supporting their proposals for revising the standard made at the 2014 session of the Specialized Section. The delegations will continue work on the text of the standard, particularly on the minimum requirement provisions for the depth and surface area of subepidermal stains. The Specialized Section will review the provisions on tolerances proposed at the 2013 session. The 2014 post-session text of the standard will be used.

(g) Tomatoes

The delegations will revisit the 2014 post-session text of the standard to decide on whether to delete "cherry tomatoes" from the commercial types listed in the "Definition of produce" section.

6. Traceability

Based on a discussion at the OECD Scheme for the Application of International Standards for Fruit and Vegetables, the delegations of France, Hungary and Poland have requested a discussion on how marking or labelling provisions of the standards could support traceability.

7. Food waste related to the use of standards

As a result of the discussion held at the 2014 meeting, the Specialized Section set up a Working Group, composed of the delegations of France, Germany, Malaysia, Sweden (Rapporteur), United Kingdom and the United States. The Working Group will report on their activity and make suggestions on future work.

8. Glossary of Terms used in UNECE Standards

The 2014 session of the Working Party formed a Working Group, composed of France (Rapporteur), Germany, New Zealand, Poland, United Kingdom and the United States, to advance work on the Glossary of Terms used in UNECE standards on fresh fruits and vegetables and invited the Group to report to the 2015 session.

9. Standard Layout for explanatory text in UNECE brochures

The delegations will consider a standard layout for the explanatory text in brochures developed by UNECE. This text could be the basis for future work on brochures. Being harmonized with the standard layout text for explanatory notes of the OECD Scheme it would also facilitate the translation of OECD brochures into Russian when needed. The Specialized Section may wish to take a decision on recommending the standard layout for explanatory text to the Working Party for approval.

10. Coordination of work with other international organizations

12. Future work

The Specialized Section will discuss its future work.

The Specialized Section may wish to decide whether the following standards, last amended in 2010, need to be reviewed in 2016: anonas, artichokes, asparagus, aubergines, avocados, beans, berry fruit, broccoli, Brussels sprouts, carrots, cauliflower, ceps, cherries, cucumbers, courgettes, kiwifruit, peaches and nectarines, peas, ribbed celery, rhubarb, root and tubercle vegetables, strawberries, and table grapes.

13. Other business

Any other issues of interest for the work of the Specialized Section can be discussed under this agenda item.

14. Election of officers

The Specialized Section will elect a Chair and Vice-Chair. At its sixty-second session, it elected Ms. Ulrike Bickelmann (Germany) as Chair and Ms. Kristina Mattsson (Sweden) as Vice-Chair.

15. Adoption of the report

The Specialized Section will adopt the report of the session.
