- SafeTIR messages received: **1'946'009**
- Percentage of messages transmitted within 1 day (*): **85%**
- Average transmission delay: **2.4 days**
- Countries transmitting within 1 day: **22 countries**
- Customs queries through the RTS database: **3'127'538**
- Reconciliation requests: **10'547**
- Replies to reconciliation requests: **6'643 (63%)**
- Average deadline for reply: **41 days**
