#### A. WP.29 session

#### 1. ADOPTION OF THE AGENDA

In accordance with Chapter III, Rule 7 of the Rules of Procedure of WP.29 (TRANS/WP.29/690), the first item on the provisional agenda is the adoption of the agenda.

#### 2. COORDINATION AND ORGANIZATION OF WORK

- 2.1. The Chairman of the Administrative Committee for the Coordination of Work (WP.29/AC.2) will report on the discussions held during its seventy-eighth session and submit its proposals for consideration by WP.29.
- 2.2. WP.29 might wish to consider the update to the Programme of Work, including the list of documents under consideration, as proposed by the Administrative Committee (WP.29/AC.2) and by the Chairmen of its respective subsidiary Working Parties (TRANS/WP.29/2002/1/).

WP.29 decided at its one-hundred-and-twenty-third session that the proposal for Draft Rule No. 2 to be annexed to the Agreement should be examined in March 2002, after an expert advice was received from CITA. It was also agreed that only after that the Draft Rule No. 2 should also be examined by GRRF, GRE and GRSG (TRANS/WP.29/776, paras. 94 and 95). In view of the information provided by CITA

during the one-hundred-and-twenty-fifth session, the consideration of this item is postponed to June 2002, at the earliest (TRANS/WP.29/815, para. 116). For the same reason, no session of the Administrative Committee (AC.4) of the Agreement is scheduled.

#### 7. OTHER BUSINESS

- 7.1. WP.29 agreed to consider measures for achieving uniform application of type approval procedures, on the basis of a proposal by the United Kingdom. To allow for effective evaluation of the proposed measures, WP.29 agreed to provide additional time for the discussion, and call an informal meeting of the Administrative Committee (AC.1) of the 1958 Agreement (TRANS/WP.29/815, paras. 21 and 24).
- 7.2. The secretariat will inform WP.29 of the progress in publishing the second issue of the "Blue book", following the adoption of its draft during the one-hundred-and-twenty-fourth session (TRANS/WP.29/815, para. 117).
- 7.3. WP.29 agreed to consider the question of replacement parts, on the basis of a document tabled by OICA (TRANS/WP.29/815, para. 120).

#### 8. ADOPTION OF THE REPORT

In accordance with established practice, WP.29 will adopt the report on its one-hundred-and-twenty-sixth session on the basis of the draft prepared by the secretariat.

The report shall also include sections referring to the

- (i) Twentieth session of the Administrative Committee (AC.1) of the 1958 Agreement;
- (ii) Fourth session of the Executive Committee (AC.3) of the 1998 Agreement.

#### B. <u>Sessions of the Administrative/Executive Committees</u>

#### 1. 1958 AGREEMENT - TWENTIETH SESSION OF AC.1

1.1. ESTABLISHMENT OF THE AC.1

The Administrative Committee shall be composed of all the Contracting Parties in accordance with the rules of procedure set out in Appendix 1 of the 1958 Agreement (E/ECE/324-E/ECE/TRANS/505/Rev.2, Article 1, para. 2).

#### 1.2. ELECTION OF OFFICERS

For the three sessions to be held in 2002, the Committee shall elect a Chairman and Vice-Chairman (Appendix 1, Article 3).

#### 1.3. DRAFT AMENDMENTS TO EXISTING REGULATIONS - VOTING BY AC.1

Amendments to Regulations shall be established by the Administrative Committee according to the procedure indicated in Appendix 1. Proposed amendments to Regulations shall be put to the vote. Each country, Contracting Party to the Agreement applying the Regulation, shall have one vote. A quorum of not less than half of the Contracting Parties applying the Regulation is required for the purposes of taking decisions. For the determination of the quorum, regional economic integration organizations, being Contracting Parties to the Agreement, vote with the number of votes of their Member States. The representative of a regional economic integration organization may deliver the votes of those of its constituent sovereign countries which apply the Regulation. Draft amendments to Regulations shall be established by a two-thirds majority of those present and voting (Article 12 and Appendix 1).

Contracting Parties experiencing difficulties in attending the sessions of the Administrative Committee AC.1 might be allowed exceptionally to express their views on items considered in writing, or by delegation of their voting power to other Contracting Parties attending the session (TRANS/WP.29/482, para. 11).

If all Contracting Parties to the Agreement agree, any Regulation adopted under the terms of the unamended Agreement may be treated as though it was a Regulation adopted under the terms of the amended Agreement (Article 15, para. 3).

#### 1.4. NEW DRAFT REGULATIONS - VOTING BY AC.1

The Contracting Parties shall establish, through an Administrative Committee made up of all the Contracting Parties in conformity with the rules of procedure set out in Appendix 1 and on the basis of the following articles and paragraphs, Regulations for wheeled vehicles, equipment and parts which can be fitted and/or be used on wheeled vehicles (Article 1, para. 1).

Proposed new Regulations shall be put to the vote. Each country, Contracting Party to the Agreement, shall have one vote. A quorum consisting of not less than one-half of the Contracting Parties to the Agreement is required for the purpose of taking decisions. For the determination of the quorum, regional economic integration organizations, being Contracting Parties to the Agreement, vote with the number of votes of their Member States. The representative of a regional economic integration organization may deliver the votes of its constituent sovereign countries. New Draft Regulations shall be established by a two-thirds majority of those present and voting (Appendix 1, Article 5).

#### 2. 1998 AGREEMENT - FOURTH SESSION OF THE EXECUTIVE COMMITTEE AC.3

#### 2.1. OPEN MEETING

#### 2.1.1. Election of officers

The Committee shall elect a Chairman and Vice-Chairman from its membership, limited to the Contracting Parties (Annex B, Articles 1 and 6).

- 2.1.2. Expecting the official presentation of the priorities for developing future global technical regulations by the European Community, AC.3 may wish to select priority items to be assigned to the subsidiary Working Parties of WP.29 (TRANS/WP.29/815, paras. 154-156).
- 2.1.3. AC.3 may wish to consider the proposal by the United States of America for a candidate global technical regulation concerning onboard diagnostic systems for heavy-duty vehicles and engines. Also tabled is proposal by Canada concerning a candidate global technical regulation on the location and identification of hand controls, tell-tales and indicators.
- 2.1.4. AC.3 may wish to have an exchange of views on the format of preambles to future global technical regulations.
- 2.1.5. AC.3 might wish to resume its consideration of the provisions of the 1998 Agreement, if requested by any of the Contracting Parties. The delegations are kindly requested to bring their copies of informal document AC.2-2, which had been distributed during the third session of AC.3, in November 2001 (TRANS/WP.29/815, para. 165).

#### 2.2. CLOSED MEETING

- 2.2.1. The Contracting Parties to the Agreement are expected to resume consideration of the questions related to the operation and implementation of the Agreement.
- 2.2.2. AC.3 might wish to consider any actions by the Contracting Parties, in view of achieving effective functions of the Agreement.
