This document contains an additional list of amendments to annexes A and B of ADR adopted by the Working Party at its eightieth session (8-12 May 2006) for submission for acceptance to Contracting Parties to ADR and for entry into force on 1 January 2007 (See TRANS/WP.15/185, par. 85 and 86).

**PART 1**

1.1.3.6.2 In the sixth indent, replace "8.1.2.1 (a) and (c)" with "8.1.2.1 (a)".

1.2.1 In the definition of "*GHS*", insert "the first revised edition of" after "means" and replace "ST/SG/AC.10/30" with "ST/SG/AC.10/30/Rev.1".

In the definition of "*RID*", replace "Annex 1 to Appendix B (Uniform Rules Concerning the Contract for International Carriage of Goods by Rail) (CIM) of COTIF" with "Appendix C of COTIF".

1.6.3.13 Delete.

- 1.6.4.10 Delete.
- 1.6.5.3 Delete.
- 1.6.5.4 Replace "31 December 2004" and "31 December 2005" with "31 December 2006" and "31 March 2008" respectively.
- 1.7.1.1 Replace "1996 edition (as amended 2003), Safety Standards Series No. TS-R-1, IAEA, Vienna (2004)" with "2005 edition, Safety Standards Series No. TS-R-1, IAEA, Vienna (2005)".
- 1.8.5.4 Under item 7 of the *Report on occurrences during the carriage of dangerous goods*, replace "Load security" with "Faulty load securing".

## PART 2

- 2.2.62.1.12.1 Replace the text of footnote 6 (current footnote 4) with the following text:

*"<sup>6</sup> Regulations governing the carriage of live animals are contained in, e.g. Directive 91/628/EEC of 19 November 1991 on the protection of animals during transport (Official Journal of the European Communities No. L 340 of 11.12.1991, p.17) and in the Recommendations of the Council of Europe (Ministerial Committee) on the carriage of certain animal species."*

- 2.2.62.1.12.2 Add a reference "<sup>7</sup>" to a footnote at the end. The footnote will read as follows:

*"<sup>7</sup> Regulations for dead infected animals are contained e.g. in Regulation (EC) No. 1774/2002 of the European Parliament and of the Council of 3 October 2002 laying down health rules concerning animal by-products not intended for human consumption (Official Journal of the European Communities, No. L 273 of 10.10.2002, p. 1)."*

(b) If empty vehicles and containers, uncleaned, are carried to the nearest place where cleaning or repair can be carried out in accordance with the provisions of 7.5.8.1, the following additional entry shall be made in the transport document: "**Carriage in accordance with 7.5.8.1**".

5.5.1 Delete and include the following text:

"5.5.1 (Deleted)".

6.10.3.7 (a) Insert "a rotation crown wheel can be fitted between the shell or the bend and the external stop valve, if this rotation crown wheel is located in the protected area and the stop-valve control device is protected with a housing or cover against the danger of being wrenched off by external loads;" at the end.

7.4.2 In the first sentence, insert "EX/III," before "FL". Add a new first indent to read: "Where an EX/III vehicle is prescribed, only an EX/III vehicle may be used;".

## **PART 9**

9.1.1.2 Definition of "AT vehicle", in sub-paragraph (a), replace "other than FL or OX" with "other than an EX/III, FL or OX vehicle".

Chapter 9.3 Add at the end of the heading: "INTENDED FOR THE CARRIAGE OF EXPLOSIVE SUBSTANCES AND ARTICLES (CLASS 1) IN PACKAGES".

Chapter 9.7 In the heading, insert "EX/III," before "FL".

9.7.7.2 In the first sentence, insert "1.5," before "3".
