REGULATION No. 48**

(Installation of lighting and light-signalling devices)

Paragraph 1., amend to read (including the insertion of a reference to a new footnote 1/ and a new footnote 1/):

"1. SCOPE

This Regulation applies to vehicles of categories M, N, and to their trailers (category O) 1/ with regard to the installation of lighting and light-signalling devices.

1/ As defined in Annex 7 to the Consolidated Resolution on the Construction of Vehicles (R.E.3), (document TRANS/WP.29/78/Rev.1/Amend.2 as last amended by Amend.4)."

Paragraphs 2.7.3., 2.7.4., 2.7.5. and 2.7.6., the reference to footnote 1/ and footnote 1/, renumber as footnote 2/.

Paragraph 2.7.25., the reference to footnote 2/ and footnote 2/, renumber as footnote 3/.

Paragraph 4.4.1., the reference to footnote 3/ and footnote 3/, renumber as footnote 4/ and amend to read:

"4/ 1 for Germany, 50 for Malta, 51 for the Republic of Korea, [52 for Malaysia and 53 for Thailand]. Subsequent numbers shall be assigned "

Paragraph 5.15., the references to footnotes 4/ and 5/ and footnotes 4/ and 5/, renumber as footnotes 5/ and 6/.

Paragraph 6.2.4.2., the reference to footnote 6/ and footnote 6/, renumber as footnote 7/ and amend to read:

"7/ As defined in Annex 7 to the Consolidated Resolution on the Construction of Vehicles (R.E.3), (document TRANS/WP.29/78/Rev.1/Amend.2 as last amended by Amend.4)."

Paragraph 6.2.9., the reference to footnote 7/ and footnote 7/, renumber as footnote 8/.

Paragraph 6.19., the reference to footnote 8/ and footnote 8/, renumber as footnote 9/.
