SPECIAL AUTHORIZATIONS, DEROGATIONS AND EQUIVALENTS

Submitted by the Central Commission for the Navigation of the Rhine (CCNR)

Under ADN 1.5.3.1, a competent authority may agree to the use or the presence on board of other materials, installations or equipment or the adoption of other construction measures or other fixtures than those required by ADN if, in line with recommendations established by the Administrative Committee, they are accepted as equivalent.

This procedure copies the one in ADNR, where it is CCNR that issues the recommendations.

Since the inception of ADNR, CCNR has issued recommendations. The list of vessels currently benefitting from such recommendations appears below:
