

Proposed amendments to the draft ECE Regulation on pedestrian protection  
ECE/TRANS/WP29/GRSP/2009/10  
Transmitted by the expert of OICA

Paragraph 3.2.1, amend to read:

"3.2.1. **The manufacturer shall submit to the approval authority the information document, established in accordance with the model set out in Part 1 of Annex I, including** a description of the vehicle type with regard to the items mentioned in paragraph 2.36., together with dimensional drawings. The numbers and/or symbols identifying the vehicle type shall be specified.

Paragraph 4.3., amend to read:

"4.3. Notice of approval or of refusal or withdrawal of approval pursuant to this Regulation shall be communicated to the Parties to the Agreement which apply this Regulation by means of a form conforming to the model in Annex 1, **Part II** and photographs and/or plans supplied by the applicant being in a format not exceeding A4 (210 x 297 mm), or folded to that format, and on an appropriate scale.

Annex I, insert the following Part I and rename the existing Annex I as "Annex I, Part 2"

If the systems, components or separate technical units have electronic controls, information concerning their performance shall be supplied.
