### **Introduction**

Directive 2008/68/EC of the European Parliament and of the Council of 24 September 2008 on the inland transport of dangerous goods establishes rules for the transport of dangerous goods within or between Member States. The directive covers transport by road, rail and inland waterways. Member States that

- i) do not have inland waterways; or
- ii) whose inland waterways are not connected to other Member States inland waterways by an inland waterway link; or
- iii) have no dangerous goods carried on their inland waterways

may decide not to apply the provisions regarding transport of dangerous goods by inland waterways.

The Member States listed in the annex have indicated to the European Commission that they have decided not to apply the provisions relating to the transport of dangerous goods by inland waterways.

The European Commission wishes to convey this information to all ADN contracting parties and to industry associations.
